Appointments of Deputy Mayor, members of Standing Policy Committees, and Personnel Subcommittee – November 17 to December 31, 2020

ISSUE

This report seeks approval with respect to appointing a Deputy Mayor and members of the Standing Policy Committees and Personnel Subcommittee for the remainder of 2020.

RECOMMENDATION

1. That City Council issue direction with respect to the vacancy on the Personnel Subcommittee for the remainder of 2020; and
2. That the recommended appointments of Deputy Mayor, members of the Standing Policy Committees and Personnel Subcommittee for the remainder of 2020, as described in the report of the City Clerk dated November 16, 2020, and listed in Appendix 1 and 2, be approved.

BACKGROUND

Section 6 of Bylaw No. 9170, *The Procedures and Committees Bylaw, 2014* provides for the first meeting of Council to be held the first Monday following a general election. At the first meeting, Council shall appoint a Deputy Mayor and members of the Standing Policy Committees for the remainder of the current year.

In addition, City Council established the Personnel Subcommittee to be a standing committee of Council by resolution at its Regular Business Meeting of March 27, 2017. The Personnel Subcommittee is comprised of the Mayor and three Councillors, appointed annually.

DISCUSSION/ANALYSIS

Pursuant to *The Cities Act*, City Council is required to appoint a Deputy Mayor.

The Deputy Mayor is to act as the Mayor if the Mayor is unable to perform the duties of Mayor, or the office of Mayor is vacant. Council shall appoint an Acting Mayor if both the Mayor and the Deputy Mayor are unable to perform the duties of Mayor, or both the office of the Mayor and the office of Deputy Mayor are vacant. The Acting Mayor shall be the Council member who was last elected as Deputy Mayor.

In the past, City Council has appointed the Deputy Mayor on a reverse alphabetical basis with a monthly rotation. Due to the Civic Election held on November 9, 2020, postponed to November 13, 2020, it is necessary to appoint a Deputy Mayor for the remainder of 2020.

Appointments of Deputy Mayor, members of Standing Policy Committees, and Personnel Subcommittee – November 17 to December 31, 2020

In accordance with the above, it would be in order to appoint Councillor Davies as Deputy Mayor for November 17th through 30th, and Councillor Block as Deputy Mayor for December, 2020. These recommendations are reflected in Appendix 1.

Recommendations for appointments to the four Standing Policy Committees and Personnel Subcommittee to the end of 2020 are outlined in Appendix 2. It should be noted all members of Council sit on the Governance and Priorities Committee.

OTHER IMPLICATIONS

There are no privacy, legal, social, or environmental implications identified.

NEXT STEPS

The 2021 Appointments for Deputy Mayor, Standing Policy Committee and Personnel Subcommittee members, and other Boards and Committees (with the exception of Statutory Boards and Controlled Corporations), will be considered by City Council at its organizational meeting, as part of the Regular Business Meeting on November 30, 2020, along with the 2021 Council and Committee Meeting Schedule.
