Chief Cooper spoke to the following:

- Saskatchewan Government is developing a new Saskatchewan Marshals Service (SMS). The SMS will be based out of Prince Albert and consist of approximately 70 officers. Chief Cooper will update the Board as more information becomes available;
- SPS officer-involved shooting on October 27, 2022 in the 1300 block of Avenue E North. The Regina Police Service is conducting the investigation;
- Homicide on November 5, 2022 in the 200 Block of 3rd Avenue
  South. A 22 year old female has been charged with manslaughter;
- Homicide on November 16, 2022 in the 100 block of Avenue P South. A 25 year old man has been charged with second degree murder;
- November 20 to 26, 2022 National Restorative Justice Week; and
- SPS Staff attended open houses of the Saskatoon Tribal Council Wellness Centre in Fairhaven. SPS is working with staff of the wellness centre to determine the kind of response that would best suit the location.

## 3.3 Using Year End Surplus for Capital Contribution

A report of the Chief of Police dated November 8, 2022, was provided.

Chief Cooper introduced the matter. SPS Executive Director Arscott presented the report.

That the Saskatoon Police Service (SPS) add to policy the opportunity to use a portion of year-end surplus from the SPS Operating Budget to contribute to a capital reserve with the following parameters:

- Purpose to increase capital reserves to accommodate capital purchases as approved within the annual capital budgets
- Funding source In years that result in a year-end surplus, all or a portion of that surplus may be transferred into the Capital Reserve identified by the SPS based upon the Chief's recommendation to the Board of Police Commissioners. Any

remaining surplus, not contributed to the SPS Fiscal Stabilization Reserve, would continue to be returned to the City

- Eligible expenditures approved capital projects as approved by the Board and Council during normal or out of cycle capital budget approvals
- **Contribution cap** The total contribution eligible in any given year will be capped at 1% of approved operating expenditures. There is no cap on the balance sitting in the various capital reserves.
