1.6 Chief's Report

Chief Cooper spoke to the following:

- Crime statistics year to date: Dispatch calls for service are up 9% which equates to 3400 additional calls as compared to last year.
- Continuing to monitor the Emergency Wellness Centre and two distinct areas, the residential area (Fairhaven) and the business community (Confederation Shopping Centre). Fairhaven has seen increased activity with 60% of the calls being social disorder calls (mental health, suspicious person, etc.).
- On June 6, 2023, SPS VICE Unit conducted a traffic stop in the 1900 block of Kenderdine Road and later executed a search warrant in the 200 block of Epp Place resulting in seizure of over 500,000 illegal cigarettes, two vehicles and \$24,624 in cash. A second search warrant was executed on June 7, 2023, in the 100 block of Fairbrother Court resulting in seizure of an additional 450,000 cigarettes.
- Acknowledged Deputy Chief Mitch Yuzdepski retirement in July after 36 years with the service.
- Superintendent Pat Nogier has been seconded by the Prince Albert Board of Police Commissioners to act as Interim Police Chief in Prince Albert.
- June 1, 2023 Peace and Respect Awards. Event hosted with Indigenous Women and Two-Spirit Advisory Circle to honour youth who are actively promoting peace and respect in their school and community.
- July 12, 2023 SPS Annual BBQ and 120th Anniversary.
