A letter and information package from Julia Adamson, Friends of the Saskatoon Afforestation Areas Inc., dated November 6, 2019 requesting permission to make a presentation to the Municipal Heritage Advisory Committee was provided, along with an additional letter dated December 2, 2019.

Julia Adamson addressed the Committee regarding the importance and reason to designate the Richard St. Barbe Baker Afforestation Area as a historical site and asked the Committee for consideration to speak to the Municipal Heritage Advisory Committee regarding the matter. An information document was provided to the Committee.

The Committee was informed that the Standing Policy Committee on Environmental, Utilities and Corporate Services at its meeting held on December 2, 2019, considered a similar request from Julia requesting to present to the Saskatoon Environmental Advisory Committee. The Standing Policy Committee on Environment, Utilities and Corporate Services determined that a presentation to the Saskatoon Environmental Advisory Committee was premature and resolved that the Administration report on the implications and considerations of Heritage designations of the afforestation area through the appropriate committee.

Discussion around places that serve alcohol (consumption sites) was held and it was determined that regulations in this regard are more complex and separate from regulating retail locations.

The Chair noted the item was for information only and no decisions could be made on the regulations at this meeting. A decision report for this matter will be reviewed by the Municipal Planning Commission and further submitted to the Public Hearing Meeting of City Council.

Licensing and Permitting Manager Wilson presented the report with a PowerPoint and responded to questions of the Committee.

Geri Fernet addressed the Committee regarding the matter highlighting concerns with rental suites compared to owner occupied suites in condominiums. Her speaking notes were submitted to the City Clerk's Office to be joined to the file.

Jim Bence, Saskatchewan Hotel and Hospitality Association, addressed the Committee regarding the lack of regulations for short-term accommodations compared to the regulations and standards that hotels need to adhere to.

Jaret Waddell, President/CEO, Globelx Management Corp, addressed the Committee regarding the impact of the short-term accommodation and home-sharing industry has had on the hotel industry. He requested that consideration be given regarding impact to the hotel industry when making the final decisions on the short-term accommodation regulations.

Alisa Thompson, addressed the Committee regarding concerns of short-term accommodations being occupied for more than 30 days noting that short-term accommodations can be removed immediately whereas the traditional rental regulations do not allow removal of tenants as easily.

Veronica Kilpatrick addressed the Committee in favour of shortterm accommodations noting they are managed by the host and reflects a consumer freedom of choice market.

Katherine Soule Blaser provided experiences in owning a shortterm rental and spoke in support of short-term accommodations as a good alternative to traditional rental properties.

Discussion following regarding clarity between the interests that are addressed in the proposed regulations and what the City's jurisdiction is in developing these regulations, cost comparisons between operating a hotel versus a short-term accommodation and potential risks to the housing rental market.

- That the Administration provide a decision matrix that clarifies which public interests the proposed regulations address, if there are areas of concern raised that the Administrative recommendations do not address, and clarification of what the City's jurisdiction is in developing these regulations, with a report provided for the Municipal Planning Commission consideration of this matter.
- That the Administration provide a cost comparison of the municipal costs associated with operating a Hotel or Motel versus a Short Term Accommodation in the rental property of a host with a report provided to Municipal Planning Commission of this matter.
