### 5.1 Mildred Kerr - Safe Transportation for III Disabled Riders of Special Needs Transport [File No. CK 7305-1]

At the November 8, 2019 meeting of the Saskatoon Accessibility Advisory Committee, the Committee had considered a letter referred from the

October 7, 2019 meeting of the Standing Policy Committee on Transportation. The Standing Policy Committee on Transportation in part resolved that the letter be referred to the Saskatoon Accessibility Advisory Committee for feedback.

The Saskatoon Accessibility Advisory Committee heard from the following speakers:

This matter was deferred until further information could be provided from the Administration prior to sending feedback to the Standing Policy Committee on Transportation.

A request to speak, from Mildred Kerr, dated January 9, 2020 was provided.

Mildred Kerr expressed concern regarding the access transit trips of those on their way home from having dialysis treatments and requested prioritization of these trips.

Access Transit Manager Loewen informed the Committee that Access Transit is a shared ride service and prioritizing rides is discriminatory. She informed the Committee that there has been an increased demand and their current capacity does not meet the demand. It was noted that the City of Saskatoon licensed taxis charge a meter rate which can be higher than the fee to ride Access Transit. The Committee was further informed that early statistics show that the Access Transit services provided on Saturday are being utilized. Access Transit has been in discussions with agencies to seek assistance to meet the demand of the riders. The Committee was also informed that Access Transit receives \$28,000 in funding from Saskatchewan Health Authority which is used for operating expenses. This funding has not been increased since approximately 2010.
