WHEREAS international, national and provincial public health and infection disease agencies and specialists recommend and advise that persons should practice social distancing,

and in some cases, self-isolation during the COVID-19 pandemic;

WHEREAS City Council and its Committees hold regular meetings to discuss and decide on matters of public policy and governance of the city;

WHEREAS these meetings are held in the City Council chamber and other meeting rooms that may not necessarily allow for appropriate social distancing;

WHEREAS The Cities Act of Saskatchewan provides rules for the attendance of City Council members at meetings of Council and its Committees;

WHEREAS *The Cities Act* requires that the City Clerk shall provide notice to the public about meetings of Council and its Committees, including the attendance of members.

WHEREAS City of Saskatoon Bylaw No. 9170, *The Procedures and Committees Bylaw, 2014*, enacts additional procedures for remote or electronic participation of members of Council at Council and Committee meetings.
