

Other Agencies, Boards & Commissions Established by City Council

1. **Agencies, Boards & Commissions Established by City Council under *The Cities Act***
 - (a) City Council has established under section 55 of *The Cities Act*
 - **Council Member is not required but City Council has chosen to sit**
 - Albert Community Centre Management Committee
 - Marr Residence Management Board
 - Pension Benefits Committee
 - (b) City Council has established under section 55 of *The Cities Act*
 - **Council Member is not required and City Council has chosen not to sit**
 - Social Services Subcommittee
 - Municipal Review Commission
 - (c) City Council established Appeal Boards under section 55 of *The Cities Act*
 - **City Council makes appointments but Council member does not sit**
 - City Mortgage Appeals Board
 - Access Transit Appeals Board
 - (d) City Council Local Appeal Boards established under section 329 of *The Cities Act*
 - **City Council makes appointments but Council member does not sit**
 - The Property Maintenance Appeal Board
 - The Fire Appeal Board
 - The Private Swimming Pool Appeal Board
 - The Saskatoon Licence Appeal Board
 - The Environmental Management Appeal Board
 - (e) City Council established Appeal Board under section 192 of *The Cities Act*
 - **City Council makes appointments but Council member is not permitted to sit**
 - Board of Revision

- (f) City Pension Boards
- **Council Member is not required but City Council has chosen to sit**
 - General Superannuation Plan for Employees of the City of Saskatoon not Covered by the Police and Fire Departments' Superannuation Plans
 - The City of Saskatoon Fire and Protective Services Department Superannuation Plan (for employees with service before January 1, 2016)
 - Saskatoon Fire Fighter's Pension Plan (for employees with service commencing January 1, 2016)
 - Defined Contribution Pension Plan for Seasonal and Non-Permanent Part-Time Employees of The City of Saskatoon

2. Agencies, Boards & Commissions Established by the Board of Police Commissioners

- (a) Board of Police Commissioners Pension Boards
- **Council Member is not required but Commission has appointed**
 - Retirement Plan for Employees of the Saskatoon Board of Police Commissioners (for employees with service before January 1, 2016)
 - Saskatoon Police Pension Plan (for employees with service commencing January 1, 2016)

3. Agencies, Boards & Commissions Established by City Council under *The Planning and Development Act, 2007 (P&D Act)*

- (a) City Council has established under section 97 of the P&D Act
- **Council member is required to sit**
 - Corman Park-Saskatoon District Planning Commission
- (b) City Council has established under sections 49 & 213-214 of the P&D Act
- **City Council makes appointments but Council member is not permitted to sit**
 - Development Appeals Board
- (c) City Council has established under section 95 of the P&D Act
- **Council member is not required but City Council has chosen to sit**
 - Municipal Planning Commission

4. Agencies, Boards & Commissions Established by City Council – Subject of Separate Reviews

- (a) Controlled Corporations - established under *The Cities Act*
 - **Two Councillors sit on each Board of Directors – not mandatory**
 - The Art Gallery of Saskatchewan Inc.
 - Saskatoon Centennial Auditorium and Convention Centre Corp.
 - Saskatchewan Place Association Inc.

- (b) Business Improvement Districts - established under *The Cities Act*
 - **One member of Council to sit on each Board of Directors – not mandatory**
 - 33rd Street BID
 - Riversdale BID
 - Downtown BID
 - Sutherland BID
 - Broadway BID

- (c) Statutory Boards - established under other provincial legislation
 - **Requirements for composition of Boards of Directors prescribed – mandatory**
 - Saskatoon Board of Police Commissioners
 - Saskatoon Public Library Board

- (d) Advisory Committees - established under *The Cities Act*
 - **One member of Council to sit on each Committee (non-voting) – not mandatory**
 - Saskatoon Environmental Advisory Committee
 - Diversity, Equity & Inclusion Advisory Committee
 - Public Art Advisory Committee
 - Municipal Heritage Advisory Committee
 - Saskatoon Accessibility Advisory Committee

- (e) Other – established under *The Cities Act*
 - **Three members of Council to sit**
 - Civic Naming Committee
