- That at least two outdoor pools be prioritized to be open if adequate staffing cannot be hired for all four outdoor pools and the indoor facilities; and
- That the Administration attempt to hire an adequate staffing complement to provide for the playground programming to occur in each location that has a standalone building as well as the paddling pools that can be accommodated through staffing needs.
