Geoff Conn, The Pot Shack, expressed concerns with the province lifting the cap on cannabis licenses creating an over saturated market.

Cierra Sieven-Chuback, Living Skies Cannabis, expressed concerns with the province lifting the cap on cannabis licenses and

asked the Committee to reconsider the number of retail stores in the City and the separation distance between them.

Jason Drummond, Jimmy and Jane Retail Corp. expressed his support with allowing a free-enterprise environment and allowing natural competition.

Andrew Gordon, Kiaro, expressed support and the opportunity for growth in the retail sector.

It was noted Warren Matzelle, Westleaf Retail Inc., was not available.
