## Re: Civic Naming Committee Report – First and Second Quarters 2020 (File No. CK. 6310-1)

Please consider the following at your meeting scheduled for August 17, 2020.

At its meeting held on June 18, 2020, the Civic Naming Committee considered a deferred submission ('Fogarty') and two reports of the General Manager, Community Services Department, requesting the Committee's direction with respect to an additional list of Chief Mistawasis Bridge naming residual submissions and multiple new general naming requests.
