

BYLAW NO. 9735

The Street Closing Bylaw, 2021

The Council of The City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Street Closing Bylaw, 2021*.

Purpose

2. The purpose of this Bylaw is to permanently close a portion of King Street adjacent to 75 and 88 King Street, Saskatoon, Saskatchewan.

Closure of Portion of Street

3. All those portions of King Street, Saskatoon, Saskatchewan, more particularly described as:

All that portion of road S1 (King Street) shown on Registered Survey Plan 78S22486 in the Northwest $\frac{1}{4}$ of Section 33, Township 36, Range 5, West of the 3rd, as shown within the bold dashed line on a Plan Showing Proposed Road Closure prepared by Brad J. Luey, Saskatchewan Land Surveyor, dated January 19, 2021;

and attached as Schedule "A" to this Bylaw, is closed.

Authorization to Carry Out Bylaw

4. The Mayor and City Clerk are authorized to execute all such documents as may be necessary to carry out the intent of this Bylaw.

Coming Into Force

5. This Bylaw shall come into force on the day of its final passing.
