BYLAW NO. 9745

The Zoning Amendment Bylaw, 2021 (No. 5)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2021 (No. 5)*.

Purpose

2. The purpose of this Bylaw is to amend the Zoning Bylaw to rezone the lands described in the Zoning Bylaw from an RMTN District to an R1B District and from an FUD(H) District to an R1B(H) District and R1A(H) District.

Zoning Bylaw Amended

3. Zoning Bylaw No. 8770 is amended in the manner set forth in this Bylaw.

RMTN District to R1B District

- 4. The Zoning Map, which forms part of Bylaw No. 8770, is amended by rezoning the lands described in this section and shown as on Appendix "A" to this Bylaw from an RMTN District to an R1B District:
