To the members of the Saskatoon City Council,

My name is Cleo Nguyen, I am a postsecondary to be graduate student studying Political Studies and Psychology. I am writing to vocalize my support for the ban on conversion therapy practices in the City of Saskatoon.

It is abhorrent to think that in the year of 2021 that individuals in our city can still be subjected to practices of conversion therapy or that any business in Saskatoon is allowed to offer such services. If our city is to continue claiming to be allies of diversity and inclusion, then this is a no-brainer move for the bylaw to be passed. Otherwise, there is little that you can convince me, and the people of Saskatoon, that you remain true to your word if you cannot demonstrate so through your actions.

I am very pleased and proud that this bylaw has been drafted, but I only hope it comes goes forward with approval and becomes reality.

Our city is beautiful, it is a place full of diverse peoples who have much love to share with one another. I have seen the kindness of our citizens and the beautiful relationships that have developed, the efforts of our communities to take care of one another, and so forth.
