VIDO's track record of success, strong international reputation, research infrastructure, relationship with university-based research communities, and expertise at the intersection of animal and human health are among the reasons why VIDO's vision of becoming Canada's Centre for Pandemic Research is both exciting and achievable. VIDO has the potential to add to Canada's capacity for biomanufacturing, focus on emerging diseases, and proactively develop vaccines that are available before those diseases unleash pandemics that destroy lives and livelihoods around the world.

Closer to home, it promises to attract top talent to our city, create careers and employment for graduate students and aspiring research specialists, and spawn the development of spin-off companies to serve and support VIDO's ongoing work.

We understand that the City of Saskatoon has been asked to invest in VIDO's vision that would see the addition of a new animal facility, upgrade VIDO's capacity to containment Level 4, and trigger critical funding from other levels of government. Given the significant potential this investment holds for our community and economy, we urge you to look favourably on the request.
