Committee Mandate

The mandate of the Saskatoon Environmental Advisory Committee (SEAC) is to provide advice on matters relating to the environmental implications of City planning, programs, policies and operations, and to identify environmental issues of potential relevance to the City of Saskatoon. SEAC provides guidance on a variety of topics including:

- Climate change and reduction of Greenhouse Gas (GHG) emissions;
- Waste reduction and diversion:
- Renewable and alternative energy;
- Ecological systems and green spaces;
- Energy efficiency and building codes;
- Active and alternative transportation; and,
- Water conservation and management.

Goals and Accomplishments

The goals of SEAC in 2020 were as follows. Under each goal, a summary of the accomplishments of the Committee is provided. Due to the COVID-19 pandemic, 2020 proved to be a quiet year for SEAC, with several meetings cancelled and minimal appearance before City Council. We look forward to ramping back up in 2021. In addition, Appendix 1 provides a summary of key topics and resolutions by meeting, and Appendix 2 provides a summary of 2020 expenditures.

1. Environmental Leadership

• Encourage City Council to take a leading and innovative stance in Municipal issues in relation to the environment

SEAC reviewed the Sustainability Report: Towards a Healthy, Resilient and Regenerative Saskatoon and is glad to see the City of Saskatoon is building organizational structures to support its stated sustainability goals.

SEAC also reviewed and provided feedback on the Corporate Climate Adaptation Strategy and recognizes the need to anticipate climate change impacts on operations and services.

• Continue to advise City Council in the implementation of the Low Emissions Community (i.e. mitigation) Plan

SEAC is excited to see this plan continuing forward as it provides a foundation for greenhouse gas reduction actions within the Community. SEAC stayed up to date on activities supporting the plan, including updates to the Renewable Energy Strategy.

SEAC also reviewed the Internal Auditor Follow-up on Carbon Reduction Initiatives which identifies the critical need to resource the initiatives outlined in the Low Emissions Community Plan.

• Continue to advise City Council on Waste Reduction and Diversion files

SEAC stayed updated on waste diversion efforts, including organics and recycling programs. SEAC reviewed a report on Curbside Residential Recycling and provided feedback to EUCS on Regulatory Approaches to Enhance Waste Diversion in the Industrial, Commercial and Institutional Sector.

• Continue to advise City Council in their adoption and implementation of the Triple Bottom Line Policy and update of the Official Community Plan

SEAC reviewed the components of the Official Community Plan related to environmental topics before the update was approved by Council and was glad to see the inclusion of updated environmental policies throughout multiple sections of the updated Official Community plan.

To support the Triple Bottom Line Policy, SEAC reviewed and provided feedback on the establishment of a new Environmental Reserve and how it should be aligned with the objectives of the Triple Bottom Line Policy.

2. Sustainable Growth

 Advise on the protection of natural areas, including the Swales, through initiatives such as the Green Infrastructure Strategy and the Natural Capital Asset Valuation file

SEAC stayed up to date on progress related to the Green Infrastructure Strategy by reviewing and discussing the strategy as well as the Natural Capital Asset Valuation pilot. SEAC was glad to see good initial progress on this relatively new strategy.

3. Moving Around Sustainably

 Continue to support the progression of a Bus Rapid Transit system and implementation of the Active Transportation Plan, which are critical components of the Saskatoon Low Emissions Community Plan.

SEAC has been encouraging greater connectivity between sustainability and transportation planning efforts by recognizing the important role public transportation networks play in greenhouse gas reduction efforts. The Committee reviewed the proposed revisions to the Bicycle Bylaw.

4. Quality of Life (Community Engagement)

Continue to support community and education initiatives, such as the Student Action for a Sustainable Future

SEAC continued its support of the Student Action for a Sustainable Future. Over the last seven years, this program has involved over 3,000 students. The Student Showcase provides an opportunity for students to tell their own environmental success stories, highlight the results of their projects, and demonstrate how Saskatoon youth can become leaders in achieving greater sustainability.

Support the Environmental Cash Grants program

Each year, SEAC supports Administration in the evaluation of applications for the Environmental Cash Grants Program. In 2020, 23 applications were received and reviewed. 15 project applications were selected to be awarded funding across five themes: general, water, waste, transportation and events. A total of \$44,000 was awarded in 2020 to support environmental projects in the community.

• Maintain our education-based social media presence

SEAC continued to be active on social media. Facebook followers grew from 314 to 401 through 2020. The Committee contracted Megan Van Buskirk to support organization and preparedness for a social media campaign, which released content throughout 2020. The focus of SEAC's social media campaign in 2020 was Climate Change & Environmental Responsibility. Planning for social media activities in 2021 is currently underway.
