# 7.1.4 Update on Asset Management Funding Plan for Saskatoon Light & Power: Building a Better Electric Utility [CK 1295-1 x 2000-1]

General Manager, Utilities and Environment Gardiner introduced the report.

Director of Saskatoon Light & Power Bell provided a PowerPoint on the matter highlighting financial information on the Asset Management Funding Plan for Saskatoon Light & Power along with scenarios for reducing the funding gap and subsequently responded to questions of the Committee. The following corrections to the report were noted: Scenario 3 – the mill rate impact will not be 0.28%. It will instead be 0.2% in 2022 and 0.1% thereafter and Scenario 4 – the mill rate impact will not be 0.5%. It will instead be 0.4% in 2022 and 0.3% thereafter.

City Manager Jorgenson and Chief Financial Officer Tarasoff provided clarification regarding budget packages at time of budget review.

The meeting recessed at 11:10 a.m. and resumed at 11:25 a.m. with all members of Committee in attendance with the exceptions of Councillor Hill and His Worship Mayor C. Clark.
