Reference: Sign Permit Denial – Appeal No. 20-2021

Site: 211 19th Street East

Proposal: Proposed Wall Signs (6) with Internal Lighting

The above-noted appeal has been filed by **Seventy-Seven Signs Ltd. on behalf of Triovest Realty Advisors Inc.**, under Section 219(1)(b) of *The Planning and Development Act, 2007*. This letter has been sent to you as the registered owner or property manager of a property that has been deemed as neighbouring the subject site. The Board is required by law to send a notice in order to give the neighbouring property owners opportunity to submit comments in writing regarding the appeal.

The property is zoned **DCD1** under *Zoning Bylaw No. 8770*, and the sign permit was denied due to the following deficiencies:

1. Requirement:

Section 13.1.3.4(c) states that the regulations applicable to Signage Group No. 5 of Appendix A – Sign Regulations will govern the use of signs in DCD1 except that portable signs, billboards, superboards, electric message centres and electronic message centres (mobile) are prohibited.

Regulations governing signs in a DCD1 District are also contained in Appendix C – South Downtown Local Area Design Plan in addition to Appendix A – Sign Regulations. Section 2.1.12 of Appendix C – South Downtown Local Area Design Plan states that no internally lit signs, other than for internally lit awnings, shall be permitted.

Proposed:

Based on the information provided, the north, east and south building faces

include six internally lit wall signs.

<u>Deficiency:</u>

The six internally lit wall signs on the north, east and south building faces are not

permitted.
