# **Project Rationale**

Responds to the impacts of COVID-19 according to local needs and context.

• COVID-19 has made the Administration consider better how people use space, in particular outdoor space. As a winter city, many months of the year are spent hiding from the cold and snow instead of embracing it. Through improving the design of buildings and outdoor spaces, the City of Saskatoon (City) can encourage more outdoor activities year-round, enabling the community to come together, even when pandemic guidance/rules like physical distancing require that people stay apart. Building and open space design can impact comfort and accessibility in winter through design features such has capturing sun for warmth, protection from wind and consideration of how people use light. This project would develop Guidelines for developers and the City to use at the beginning of the design process.

The Administration's support for the project could be funded through the remaining capital funding available through the WintercityYXE Capital project.
