

Active Transportation Project – Sidewalk Locations

The Administration previously reported that many of the following sidewalk locations would be addressed through reallocation pool funding approved by City Council at their meeting on June 27, 2020. With the approval of the Investing in Canada Infrastructure Program (ICIP) funding, the Administration plans to proceed with the below noted locations as the ICIP funding for sidewalks has a requirement to spend the allocated funds by 2025. The reallocation pool funding has no time limit for spending.
