BYLAW NO. 9763

The Zoning Amendment Bylaw, 2021 (No. 12)

The Council of the City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2021 (No. 12)*.

Purpose

 The purpose of this Bylaw is to amend the Zoning Bylaw to rezone the lands described in the Bylaw from FUD and FUD(H) Districts to R1A, R1B, R2 and RMTN Districts.

Zoning Bylaw Amended
