Dear City Councillors,

I understand that on Monday, August 30, 2021, you will be discussing and voting on the subject of COVID-19 vaccine passports for Saskatoon and mandating COVID-19 vaccinations to allow individuals to move about freely or be permitted to shop, obtain services or otherwise restrict and discriminate against sectors of the population, implemented in the City of Saskatoon, Saskatchewan, Canada. This is of utmost importance and I have provided a list of relevant sources of information below for your consideration on this issue.

The fact that there is any consideration whatsoever in thinking that City Councillors or the City of Saskatoon have any right to impose such a requirement on the people of Saskatoon, and exercising such an abuse of power, tells me there is an extremely naive and misinformed level of awareness about the entire situation that's been playing out over the past 18 months. Respectfully, I know there is an extreme depth of misinformation being spread on mainstream media and by our own governments which most people use as their only source of information. I've provided resources for many of the key points below that our government authorities and mainstream media refuse to acknowledge, which would be useful prior to your meeting to better understand the issues.

There are dozens of reasons why this vaccine passport system or any further restrictive measures, should not be considered ever again, as follows:

1. [Nuremberg Code 1947](#) - mandating any experimental medical treatment is against international law, and any offering of a medical treatment must be done with full disclosure and consent of each man or woman. Currently none of the so-called 'vaccines' for COVID-19 are not given under full disclosure of the risks and potential benefits. The media, governments and medical authorities are lying, coercing, and manipulating people into taking these experimental medical treatments. Anyone participating in these deceitful practices will be charged with crimes against humanity and punished with the full extent of the law. This includes you and anyone involved at the City of Saskatoon if you choose to take this path.
2. [Right to Medical Privacy](#) - everyone has the right to medical privacy. A vaccine passport makes their medical status public.
3. [Saskatchewan Bill of Rights Act](#) – fundamental rights and freedoms of Saskatchewan residents.
4. Right to sovereignty over our body and personal decisions about medical treatments. This is one of our constitutional rights in Canada and internationally under the [Canadian Bill of Rights](#), to protect essential human rights and freedoms.
5. These experimental medical treatments referred to as COVID-19 vaccines are causing greater harm than good. Millions of people have experienced severe adverse reactions

and deaths worldwide. The United States of America's [VAERS](#) database alone has more than enough evidence reported that these should have been stopped long ago (and this is estimated to be [only 1% of actual injuries](#)). These jabs do not meet the definition of a "vaccine", as they do not prevent a disease or transmission of the disease, and their relative efficacy is less than 1% as per published research. Thousands of doctors and specialists around the world have pleaded with authorities to stop the use of these several months ago. When they sounded the alarm bells on the expected deadly and harmful outcomes their voices were censored, ridiculed, and labeled misinformation. They were right and the data today is proving it. One of the most prominent highly respected doctors has been interviewed extensively and has a lot to say about the situation, [Dr. Peter McCullough](#). This is only one of thousands of experts who have spoken out. Listen to this interview to hear about the misleading news headlines that the Pfizer jab was FDA approved (no, it wasn't!), side effects, severity, how the jabs work and how the body attacks itself (cardiovascular issues, myocarditis, damage in children and adults to name a few), and how the vaccines are an epic failure. He also provides a list of resources near the end of this interview where you can review further details of treatment guides that have been published. This will clearly show that several effective protocols are available but are being prohibited in Canada by our government and authorities.

6. All media, government and medical authority communications which promote that COVID-19 vaccines are the only way out of this so-called pandemic have been misleading us for months. Their continued censorship and denial of published research using other treatments and protocols has been a ploy to keep the Emergency Use Authorization in effect for these experimental vaccines. Further, these are gene therapy treatments in the case of the mRNA versions and have not undergone sufficient research. The health authorities dictating ineffective protocols for the treatment of SARS-CoV-2 and withholding the effective treatments (including existing drugs and nutraceuticals for example) that are available have resulted in excessive suffering and deaths, in Saskatoon and around the world. The Emergency Use Authorization is supposed to only be permitted when no other medical treatments are available. The continued blatant fraud by governments and health authorities worldwide is astounding, and the mainstream media continue to promote a single narrative. All of these experimental 'vaccines' should have been halted long ago. Here is just one of hundreds of peer reviewed published research documents about how [ivermectin](#) is helpful as part of a more comprehensive protocol, and even as a preventative treatment. For specific Canadian doctors who are speaking out against the narrative please see the [Canadian Covid Care Alliance](#). There are also similar nurses' groups, who are getting braver to speak out and will tell you that what the mainstream news and our government health authorities are saying about the situation in Canada is a lie and has been since the beginning.
7. A vaccine passport system (or masks and other restrictions) requiring businesses to mandate COVID-19 vaccines as a prerequisite for doing business with them is unfairly

putting them in an illegal position whereby they will be discriminating against sectors of the population, and subject to lawsuits. This is unfair to the businesses that have already been suffering from the lock downs and other government psychological programming around the pandemic this past several months. Please [review the letters and resources from the Canadian People's Union](#) that outline the many legal issues surrounding implementing any further lock downs, mandates for masks and vaccines, and other unlawful and useless requirements.

8. Countless people have already lost jobs, businesses have closed, and livelihoods lost because of the overreach of the governments' and health authorities' restrictions. The economic toll is too large to calculate.
9. All ages have had a severe health decline and damage to mental health and well-being due to the extreme measures already having been implemented since early 2020. Children, seniors and singles are the hardest hit with all groups suffering more without access to their families and other social supports, when restrictions are implemented that prevent normal activities of daily living. This topic has been brushed aside by all levels of government and health authorities. This harm and trauma they have caused will affect people the rest of their lives.
10. Masks are a completely useless requirement as they do nothing to prevent transmission of SARS-CoV-2 and have proven to be harmful to one's health and serve merely as a sign of submission to authority. They increase the risk of lung and other infections on the skin, reduce oxygen to the brain, and cause a stress response on the body's nervous system, to name a few of the issues. Used masks are highly contaminated with bacteria and other toxins exhaled, plus from touching them frequently by the wearer. Over 60 [research studies](#) have shown the multiple harms these do and the [consequences](#). This is also contributing to an environmental disaster as they are not disposed of properly and are made often with toxic chemicals adding further to the health risks when inhaled and contamination of the environment.
11. Excessive use of sanitizers and disinfectants are also contributing to antibiotic resistant strains of other infectious bacteria. These toxic chemicals also increase the toxic load for each person that must use them repeatedly throughout the day and causing skin irritations for many.
12. Physical (social) distancing also has been proven to be completely useless in public settings among normal healthy individuals and is merely increasing stress on the businesses and the public at large trying to accommodate for this. There is [no asymptomatic transmission, and has been shown in published research](#).
13. Excessive stress on everyone from the constant fear-mongering media, governments, and health authorities is bad for health and further diminishes our natural immune systems! This alone increases risk of infection and other diseases.

14. The continued use of [fraudulent PCR testing](#) with high numbers of false positive 'cases' is only serving to fear-monger and coerce the public into submission to all the restrictions that are publicly declared "for the greater good". These tests were never designed to be a diagnostic test for SARS-CoV-2 or any other disease. They can detect the presence of genetic material of all kinds of proteins, especially when magnified at 40 cycles. These result in false positives more than 90% of the time and are ineffective for the purposes they're being used for. Many of the swabs also have toxic chemicals on them that are carcinogenic and thus are causing further health risks for individuals exposed to them.

If governments and health authorities were truly interested in protecting our health then they would have been promoting how people can advocate to increase their health and wellness rather than continued fear mongering. Eating a healthy diet, getting exercise, fresh air, spending time with friends and family, supplementing with nutraceuticals that help prevent infections and improve immune system function, such as Vitamin D3, Vitamin C, Zinc, Selenium, Quercetin, and others, for example. [Dr. Zalenko published this](#) many months ago and those who follow these preventative protocols do well to prevent disease from SARS-CoV-2, and if they do get infected have far less severe symptoms, and a much faster recovery.

I could go on and on as there are thousands of published research studies and articles written by medical and research professionals, lawyers and other experts on the subject matters listed here, and others. I have provided a high level of information on the key topics so that you can get up to speed quickly (if you aren't already) and to share with your colleagues prior to the meeting so you can avoid making a disastrous mistake.
