I am not seeking to speak to City Counsel directly, but want to register my disapproval of the Vaccine Mandate as well as the forced mask wearing of school aged children while attending school through this e-mail.

I would like to make known my position against Mandatory Vaccine Passports that are being considered for the City of Saskatoon. The vaccines that have been developed to combat COVID-19 are still in the experimental stage and have still a long ways to go before we will know their safety record (2023). Further, these vaccines have been rushed ahead without any animal testing. The United States VAERS (Vaccine Adverse Event Reporting System) have noted 13,000 deaths and and thousands of adverse effects after vaccines have been administered. No one should have to have this yet unproven vaccine injected into their bodies against their will. School age children and young adults who have almost a zero probability of dying (0.0003 %)if they contract the COVID-19 virus certainly should not be forced to take the vaccine against COVID-19. Forcing or coercing citizens to have to take the COVID-19 vaccines directly or indirectly violates the Nurenberg Principles. There are now about eight proven protocols to fight the onset of COVID-19 so vaccines are not the only way to combat COVID-19.

This discrimination against the unvaccinated citizens constitutes breaching our Charter of Rights and Freedoms under the Canadian Constitution Act 1982. It creates a second class citizen of those that are unvaccinated and severely restricts their right to freely enjoy life in the form of travel, eating out at restaurants, going to sporting events etc. if the Vaccine Mandate is enacted. It will also force some to lose their jobs if they refuse to be vaccinated. This is unfair and discriminatory.

Further, the mask mandate for school aged children is a crime against humanity and makes no scientific sense in that the COVID-19 virus is so small it can easily escape a cloth face mask. Besides, studies show that children are very rarely spreaders of the COVID-19 virus. They need to have the right to see the facial expressions of their fellow students and their teachers. Without this some children will develop abnormal psychological and mental (depression) maladies. I fear what the long term effects of masking our students will do to them in the long term.
