9.1 CNC Resolution - Renaming Requests and Historical Context

At its meeting held on March 9, 2021, the Civic Naming Committee considered a referral from City Council with respect to a request for renaming McPherson Avenue, and resolved:

That the Administration report back with examples from other communities as to how to handle renaming requests of this nature, and in consultation with local stakeholders, include options about how Saskatoon could respond to renaming requests that come forward on the basis of historical context.

Administrator Wood provided a verbal update, noting the above resolution has initiated a larger discussion including interim and long-term measures, and requires additional time. He advised the Administration intends to report back to the September 2, 2021, Civic Naming Committee meeting.
