Dear Councillors:

The Varsity View -Grosvenor Community Association is split on the merits of a reduced speed limit in our neighborhoods. Some believe that 40 kph would be a more appropriate speed limit for many residential streets. Others are concerned about the cost and whether a speed limit bylaw change would achieve the desired effect.

We understand that reduced speed reduces the number of serious injuries and mortality. Unfortunately, perhaps because they have not been personally touched by this unpleasant fact, this is not a major concern of all our residents. We do support increased enforcement of the current speed limits and believe that speed traps on collector roads would catch people speeding and slow down some vehicles. We are concerned that speed traps are often placed in locations where the 'catch' is highest which often means that they are not in residential areas.

In summary, the lack of effective enforcement of other bylaws, including the current speed limits in residential areas, leaves many wondering whether a change would result in a benefit.

Thank you for your consideration and for helping make ours a more livable community.
