The organization is crucial to supporting the cities disenfranchised and vulnerable populations while also providing affordable living solutions. CUMFI's intent is to provide continued support to women, children, youth, and families.

With properties throughout the core neighbourhoods, CUMFI is considered one of the leading Aboriginal supported-housing and wellness community organizations in Saskatoon, Saskatchewan. Our most recent housing development, Round Prairie Elders' Lodge (412 Ave P South) in Pleasant Hill, is situated on land that boarders an industrial zone.

CUMFI continues to invest in improvements to core neighbourhoods in Saskatoon, and the organization strives for a high quality of life for residents. Location of residential neighbourhoods in close proximity to industrial companies can create challenges such as excess sound, traffic and varying air quality. As such, we encourage the City of Saskatoon to review regulations for industrial zones through the lens of the effects on nearby residential neighbourhoods and the quality of life of residents living in close proximity to these zones.
