I am writing as a concerned taxpaying citizen of this city. I ask for this letter to be considered in regards to the new proposed bylaw to intentionally target "unvaccinated" citizens.

I ask you to remember the Charter, Constitution, and Bill of Rights guaranteed to citizens in this country. I ask you to think about how this action will continue to perpetuate the mounting discrimination, polarity, division, hate, and growing segregation already present in Saskatoon and Canada.

I ask for your support to stand up for the rights of ALL taxpaying citizens, BOTH vaccinated AND unvaccinated. I ask for you all to be brave enough to fight for equality, instead of supporting the polarity and segregation that is mounting out of control and perpetuated by law makers. Many people have been subjected to major losses. A few detrimental examples are: loss of jobs, income, and benefits. Denied entry and access to a majority of establishments in the city including gyms, yoga studios, dance studios (all which when accessed contribute to both physical and mental health), auditoriums, museums, restaurants, liquor stores, arenas, and establishments where parents have lost their right and the ability to watch their children play sports, dance, paint, play an instrument, ETC.

Saskatoon residents have chosen to set roots here because they have pride in this city, were able to enjoy what it offered, and to be closer to loved ones, family members, and friends. Yet, a vote is cast to diminish this for some

(vaccinated) and COMPLETELY REMOVE this right for others (unvaccinated)? There is a lack of regard for the human essentials by depriving people of human contact, community, time with loved ones, and access to the city upon which we all pay to have access to. This bylaw will not serve one's well being, mental health, and it certainly will not strengthen and unite our community.

Please reconsider this vote.

Please be the people FOR ALL people. Please fight for unity, equality, and the rights of ALL your citizens in Saskatoon.
