Comments

I am writing as a concerned citizen and ask this to be presented either for or by Ward 5 councillor R. Donauer and my behalf as a taxpaying citizen of this city. The proposed bylaw which you, elected by the people council, are choosing to exercise bylaws that are out of the reach and legal purview of your powers. The bylaw to intentionally target "unvaccinated" citizens is both appalling and egregious. I do not understand how you feel you can usurp charter, constitutional and bill of rights GUARANTEED to citizens in this country. I have thus far, a 31 (thirty one) year career in correctional services. We (correctional services) protect the citizens of this country by "lawfully" exercising the court's proceedings to ensure that ONLY the legal rights necessary to be removed are done so with integrity, due diligence, and within the reasonable limits of the law. What the sum of you, who voted in favour of proposing is illegal, unlawful and completely appalling. I speak for all people who have the knowledge and common sense to understand the proposed restrictions. I speak for myself as a law abiding, community contributing tax paying citizen, not only of this city or province but this country. Your city police officers are excused from enforcing these, yet you are choosing to impose items beyond the scope of your work. You DO NOT have the power or responsibility of mandating public health or healthcare orders. In accordance with Blacks law dictionary, a MANDATE is not a legal or lawful order; it is not tied to legislation. It is a proposal which must be given consent. I absolutely oppose you, Mr Clark, and the councillors elected by the PEOPLE of saskatoon choosing to invest OUR TAX dollars in this divisive, exclusionary, unlawful bylaw. I oppose that these council meetings are held without public opinion or input. I oppose the treatment of citizens of this city in this manner. It opposes the good common sense and culture of this community, province and country.

I am sending a copy of this to my city council member who is doing his best to represent all people fairly. I expect this to be read to all of you. I expect to receive his comments regarding this written representation of my taxpaying (in GOOD standing) before council and God almighty.
