I am writing as a concerned taxpaying citizen of this city. I ask for this letter to be considered in regards to the new proposed bylaw that will affect all, but will mostly target unvaccinated citizens.

I ask you to remember the Charter, Constitution, and Bill of Rights guaranteed to citizens in this country. I ask you to think about how this bylaw can continue to perpetuate the mounting discrimination, polarity, division, hate, and growing segregation already present in Saskatoon and Canada.

I ask for your support to stand up for the rights of ALL taxpaying citizens, BOTH vaccinated AND unvaccinated. I ask you to fight for equality, instead of supporting the polarity and segregation that is mounting out of control and has been perpetuated by law makers.

Many people who've exercised their Constitutional rights have been subjected to major losses. A few detrimental examples are: loss of jobs, income, benefits, and stability. Denied entry and access to a majority of establishments in the city including gyms, yoga studios, dance studios (all which when accessed contribute to both physical and mental health), auditoriums, museums, restaurants, liquor stores, arenas, and establishments where parents have lost their right and the ability to watch their children play sports, dance, paint, play an instrument, ETC. So I ask why the people of this council believe it is lawful, right, just, and ethical to remove even more from these residents after seeing (only a few) examples of what they've already lost?

Saskatoon residents have chosen to set roots here here because they have pride in this city, they work here, theh support locally, enjoy what the city offers, and live here to be closer to loved ones, family members, and friends. Yet, a vote could be cast to diminish this for some (vaccinated) and COMPLETELY REMOVE this right for others (unvaccinated)? I feel there is a lack of regard for the human essentials by depriving people of human contact, community, and time with loved ones, and friends. This bylaw may very well hinder one's well being, mental health, and it certainly will not strengthen and unite our community.

Please reconsider this vote.

I hold much compassion for all who navigate this unique time, and I thank you kindly for letting my concerns marinate as you prepare for this vote and I still ask you to reconsider this vote.

Please be the people FOR ALL people. Please fight for unity, equality, and the rights of ALL your citizens in Saskatoon.
