I know your intentions are in the right place on this one, but in my opinion a bylaw without teeth is a meaningless and empty gesture. It will only achieve the following

1. Create more confusion as the list of exempted businesses may or may not match with other health orders.
 - a. Either the bylaw should cover all places that people congregate in public or what is the point. Are you actually suggesting that the hardship of putting a vaccination passport checker at the front of a grocery store is greater than the risk of exposure inside the store?
2. As bylaws are complaint driven, it will only add to divisiveness between the citizens of saskatoon
 - a. Are you expecting me to call 911 to report my neighbor who has more than x people in their house for a dinner?
3. The cost to enforce it will divert considerable resources (human and public relations) away from the city's core responsibilities.

Please just follow the province's guidelines so there is consistency. If you don't like the guidelines feel free to send a stern on the record statement to the province with council's objections, but stop this waste to time, money etc on another study into another bylaw that will literally do nothing to make a change in a practical sense.
