I am sending this letter to express my **extreme concern and opposition to the proposed COVID-19 bylaw** to be presented to City Council. I am a long-time Saskatoon resident and business owner, who is active in working and volunteering at a local church in the core of the city. I vote in every election. I keep myself informed of issues (educating myself on ALL facets of these issues) including the science and politics surrounding COVID-19. I, and many others that I know, are convinced that the policies put in place have NOT been rooted in science. The narrative promoted by the health authorities, media and politicians at all levels of government has been flawed and the information manipulated to support that narrative. This is not a “fringe” perspective. The proposed bylaw is based on this flawed narrative.

Not only is the basis for the bylaw flawed, but the intent of City Council to make, implement and enforce health policy is contrary to the distribution of powers in Canada. It is a waste of Council’s time, resources and tax dollars. It is also an overreach of the City’s powers, and since it is not proven to be supported by science, it contravenes the Canadian Constitution and Bill of Rights.
