Comments

I am writing in regard to the proposed Covid restrictions that the City of Saskatoon will be meeting in regard to today. I am a citizen of Saskatoon that opposes the proposed restrictions that the city is considering. Normally, the restrictions being proposed are passed at a provincial level. If the province has not taken this step, I am questioning why the city of Saskatoon thinks that they have better knowledge in this regard. Please understand the following:

- survival rate from covid Canada wide is 99.92%. With such a high survival rate, it does not seem reasonable to go to such extreme measures as you are proposing when our community is already to much divided on this issue.
- you should be taking steps to unite our community, not divide.
- as of yesterday, the province had 53 available ICU beds. This is not a pandemic as extreme as it is being made out to be.
- the media is fear mongering and providing only one side to the story. Doctors are being silenced and when they try to speak out, are being reprimanded (refer to Dr. Christian). It would seem worthwhile and certainly needed for you to hold a public debate with "experts" or doctors on both side being allowed to speak freely without concern for losing there jobs.
- why is not natural immunity being recognized, just like vaccination? Why has antibody testing been restricted and not allowed?

- why are doctors not being permitted to use safe medication to treat covid (for example, ivermectin)? Why is the media portraying ivermectin as a horse dewormer?
