Dear Mayor Clark and City Council:

On behalf of the residents of Meadowgreen, the Directors of Meadowgreen Community Association want the City of Saskatoon to act on the noise pollution emanating from the westside industries that operate in and around Ave P South. The Industrial-Residential Interface Study is a band aid for the systemic discrimination against poor residents. While we see it as a long overdue first step, the City must find alternative and better options for the residents in the area.

Erica Walker, an environmental health researcher and associate professor at the Brown University School of Public Health, notes that the impact from rumbling vibrations, bus engines, heavy truck engines (and trains) impact people "from mood disruptions to more serious health impacts, ranging from cardiovascular related mortality, increased prevalence and incidences of hypertension, stroke and heart attack". Please refer to this story to learn more about the effects of poor urban planning. The City of Saskatoon discriminatory urban planning now places an elder lodge next to the CP Railroad track on Ave P and the city is planning further multifamily residential housing on this street. It is incumbent on the City of Saskatoon to ensure that people in every part of the city have a safe living environment.

We hope that City Council will support the Industrial-Residential Interface Study in the 2022-23 budget.
