

# BYLAW NO. 9806

## The Zoning Amendment Bylaw, 2022 (No. 2)

The Council of the City of Saskatoon enacts:

### Short Title

1. This Bylaw may be cited as *The Zoning Amendment Bylaw, 2022 (No. 2)*.


### Purpose

2. The purpose of this Bylaw is to authorize the Rezoning Agreement which is annexed hereto as Appendix "B".

### Zoning Bylaw Amended

3. The Zoning Bylaw No. 8770 is amended in the manner set forth in this Bylaw.

### AG District to M3 District

4. The Zoning Map, which forms part of Bylaw No. 8770, is amended by rezoning the lands described in this Section and shown as  on Appendix "A" to this Bylaw from an AG District to an M3 District by Agreement:

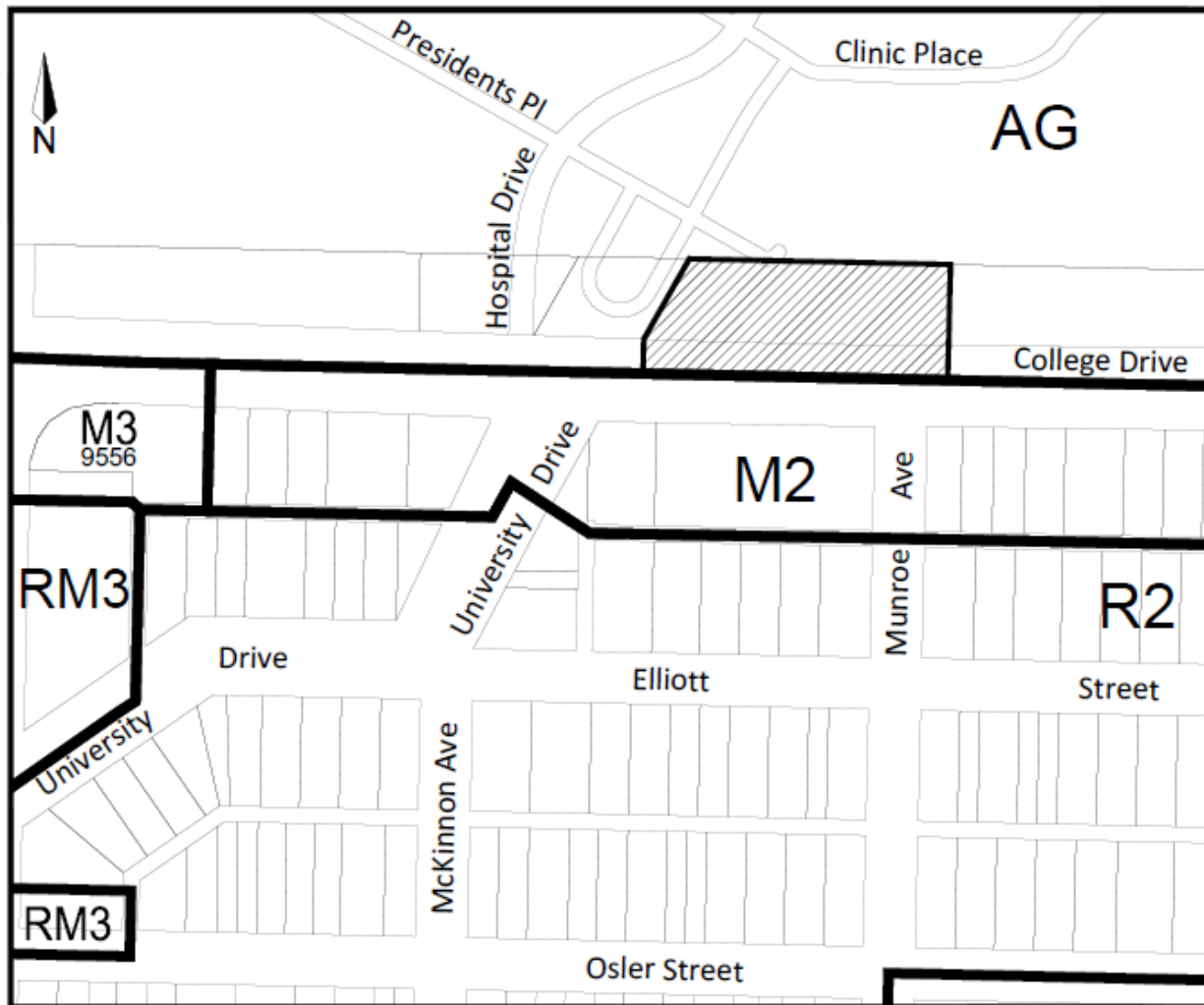

## **Appendix "B"** **Rezoning Agreement**

This Agreement made effective this 31<sup>st</sup> day of January, 2022.

Between:

**City of Saskatoon**, a municipal corporation pursuant to the provisions of *The Cities Act*, S.S. 2002, Chapter C-11.1 (the "City")

- and -

**St. Andrew's College**, a corporation pursuant to *An Act to Incorporate St. Andrew's College*, being a Private Act, S.S. 1972, Chapter 157 (the "Owner")

### **Whereas**

A. The Owner is the registered owner of the land described as follows:

(the "Land").

B. The Owner has applied to the City for approval to rezone the Land from an AG District to an M3 District to allow for the development of the proposal specified in this Agreement.

- C. The City has approved the Official Community Plan, which pursuant to Section 69 of *The Planning and Development Act, 2007*, contains guidelines respecting the entering into of agreements for the purpose of accommodating requests for the rezoning of land.
- D. The City has agreed, pursuant to the provisions of Section 69 of *The Planning and Development Act, 2007*, to rezone the Land from an AG District to an M3 District, subject to this Agreement.

Now therefore this Agreement witnesseth that the Parties hereto covenant and agree as follows:

### **Land to be Used in Accordance with Agreement**

- 1. The Owner agrees that, upon the Land being rezoned from an AG District to an M3 District, none of the Land shall be developed or used except in accordance with the terms and conditions set out in this Agreement.

### **Use of Land**

- 2. The Owner agrees that the use of the Land will be restricted to the following:
  - (a) educational Institutions
  - (b) child care centres and pre-schools;
  - (c) private schools;
  - (d) offices;
  - (e) medical clinics;
  - (f) art galleries and museums; and
  - (g) places of worship.

### **Development Standards**

- 3. The development standards applicable to the Land shall be those applicable to an M3 District except as follows:

- (a) minimum building setbacks:
  - i. front yard (south): 6.0m;
  - ii. exterior Side yard (west): 18.0m;
  - iii. interior Side yard (east): 30m; and
  - iv. rear yard (north): 1.0m.
- (b) maximum building Height: 18m
- (c) landscaping shall be as developed on the site, and approval of any changes is at the discretion of the Development Officer; and
- (d) all other development standards shall conform to the relevant Sections of the Zoning Bylaw.

### **Parking**

- 4. Parking shall be provided in accordance with the following:
  - (a) The provision of 56 at-grade parking spaces will be provided through remote parking by means of lease or other remote parking agreement;
  - (b) Remote parking may be approved where it can be demonstrated that the route to the remote parking is considered to be both safe and within a reasonable walking distance of the building and where the remote parking site is tied to the principal use site by means of lease or other remote parking agreement; and
  - (c) No loading space is required.

### **Site Plan**

- 5. Site development shall consist of the existing building and landscaping. Any site development must be substantially in accordance with the approved site plan.

### **Application of Zoning Bylaw**

- 6. The Owner covenants and agrees that, except to the extent otherwise specified in this Agreement, the provisions of the City of Saskatoon Zoning Bylaw No. 8770 as amended from time to time shall apply.

### **Compliance with Agreement**

7. The Owner covenants and agrees not to develop or use the Land unless such development, use and construction complies with the provisions of this Agreement.

### **Dispositions Subject to Agreement**

8. The Owner covenants and agrees that any sale, lease or other disposition or encumbrance of the Land or part thereof shall be made subject to the provisions of this Agreement.

### **Definitions**

9. Any word or phrase used in this Agreement which is defined in Zoning Bylaw No. 8770 shall have the meaning ascribed to it in that Bylaw.

### **Departures and Waivers**

10. No departure or waiver of the terms of this Agreement shall be deemed to authorize any prior or subsequent departure or waiver, and the City shall not be obliged to continue any departure or waiver or permit subsequent departure or waiver.

### **Severability**

11. If any covenant or provision of this Agreement is deemed to be void or unenforceable in whole or in part, it shall not be deemed to affect or impair the validity of any other covenant or provision of this Agreement.

### **Governing Law**

12. This Agreement shall be governed and interpreted in accordance with the laws of the Province of Saskatchewan.

### **Effective Date of Rezoning**

13. It is understood by the Owner that the Land shall not be effectively rezoned from an AG District to an M3 District until:

- (a) the Council of the City of Saskatoon has passed a Bylaw to that effect; and
- (b) this Agreement has been registered by the City, by way of Interest Registration, against the Title to the Land.

### **Use Contrary to Agreement**

- 14. (1) The Council of the City of Saskatoon may declare this Agreement void where any of the Land or buildings thereon are developed or used in a manner which is contrary to the provisions of this Agreement, and upon the Agreement being declared void, the Land shall be subject to all provisions of the AG Zoning District.
- (2) If this Agreement is declared void by the Council of the City of Saskatoon, the City shall not, by reason thereof, be liable to the Owner or to any other person for any compensation, reimbursement or damages on account of loss or profit, or on account of expenditures, or on any other account whatsoever in connection with the Land.

### **Registration of Interest**

- 15. (1) The Parties hereto acknowledge that this Agreement is made pursuant to Section 69 of *The Planning and Development Act, 2007* and the Owner agrees that this Agreement shall be registered by way of an Interest Registration against the Title to the Land. As provided in Section 236 of *The Planning and Development Act, 2007*, Section 63 of *The Land Titles Act, 2000* does not apply to the Interest registered in respect of this Agreement.
- (2) This Agreement shall run with the Land pursuant to Section 69 of *The Planning and Development Act, 2007*, and shall bind the Owner, its successors and assigns.



**Enurement**

16. This Agreement shall enure to the benefit of and be binding upon the Parties hereto and their respective heirs, executors, administrators, successors and assigns.
