7.3.1 City of Saskatoon Impound Lot Business Model [File No. CK. 6120-6]

"That Priority 1 Streets be cleared of snow within 12 hours, with no exceptions.

That priority 2 streets be cleared of snow within 36 hours except when windrows become dangerously high. In that case, administration will assign existing crews to (a) clear roads and (b) remove windrows on medians and bridges.

That priority 3 streets be cleared of snow within 72 hours except when windrows become dangerously high. In that case, administration will assign existing crews to (a) clear roads and (b) remove windrows on medians and bridges."
