That a provision for protected bike lanes be included in the Downtown All Ages and Abilities cycling network; 2. That the Administration develop a Downtown All Ages and Abilities cycling network (including protected bike lanes) in concert with other downtown policy and planning initiatives in 2018; 3. That the existing protected bike lanes on 23rd Street (from Spadina Crescent to Idylwyld Drive) and 4th Avenue (from 20th Street to 24th Street) be retained until the Downtown All Ages and Abilities cycling network plan is presented to City Council;

That Option 1 (3rd Avenue, 23rd Street and 19th Street) be endorsed as the future active transportation network in the Downtown, but that implementation decisions (including capital or detailed design expenses) be deferred until the administration has completed engagement based on the following criteria: <ul style="list-style-type: none"> • That the active transportation network be designed for all users, including pedestrians, cyclists, and those with accessibility needs.
