# The Procedures and Committees Amendment Bylaw, 2022

#### **ISSUE**

This report submits Bylaw No. 9820, *The Procedures and Committees Amendment Bylaw, 2022* (the "Bylaw") for City Council's consideration. The Bylaw implements City Council's decision to amend the Advisory Committee Terms of Reference.

# RECOMMENDATION

That City Council consider Bylaw No. 9820, *The Procedures and Committees Amendment Bylaw*, 2022.

#### **BACKGROUND**

At its <u>February 28, 2022 Regular Business Meeting</u>, City Council considered a report of its Governance and Priorities Committee and resolved, in part:

That amendments to the Advisory Committee Terms of Reference be approved to:

- a) Permit flexibility in the conduct of meetings to allow for virtual participation;
- b) Include a statement regarding the role of Agency Representatives;
- Update the Advisory Committee composition language contained in the Terms of Reference as provided in the report;
- d) Change the meeting schedule for the Saskatoon Environmental Advisory Committee from the second Thursday of the month to the third Wednesday of the month;
- e) Change the language in bullet 4 of the Terms of Reference for the Diversity, Equity and Inclusion Advisory Committee to reflect the Committee's role to support the provision of education and training rather than provide it; and
- f) Remove the Ministry of Environment as an Agency Representative from the Saskatoon Environmental Advisory Committee Terms of Reference and make any other consequential amendments; and

That the City Solicitor's Office prepare the appropriate amendments to The Procedures and Committees Bylaw, 2014 to reflect the changes identified in this report.

# **DISCUSSION/ANALYSIS**

The Bylaw will allow Advisory Committees to meet in person, virtually, or a combination of both (hybrid). Virtual or hybrid meetings will only be permitted when the facilities meet the same requirements as established in Schedule "O" of *The Procedures and Committees Bylaw, 2014* for remote participation at Council and Council Committee meetings.

In accordance with City Council's instruction, we are pleased to submit Bylaw No. 9820, *The Procedures and Committees Amendment Bylaw, 2022* for City Council's consideration.
