#### 5. UNFINISHED BUSINESS

## 5.1 Saskatoon Freeway Planning Study – Phase 1 Endorsement Request [File No. CK. 6000-1]

Deputy City Clerk Bryant reported that the Standing Policy Committee on Transportation, at its meeting held on March 7, 2022, deferred this matter to this meeting due to time constraints. A report of the General Manager, Transportation and Construction, dated March 7, 2022 was provided.

In addition, City Council, at its meeting held on November 22, 2021 considered a general project update and resolved:

1. That His Worship the Mayor send a letter to the Minister of Highways documenting the need and importance of completing Phase 3 of the Saskatoon Freeway planning and requesting that the Province reconsider the decision to cancel the planning work for Phase 3 of the Saskatoon Freeway project;

- 2. That the Mayor's Office consult with Reeve Harwood and/or the RM of Corman Park regarding the possibility of issuing a joint letter, signed by the Mayor and the Reeve;
- 3. That the letter be copied to the Premier and all Saskatoon area Government MLA's; and
- 4. That the letter from the Mayor ask the Minister to clarify the current direction and the expected timeframe for Phase 3 to be started.

The letter from Reeve Judy Harwood, R.M. of Corman Park with Mayor Charlie Clark, City of Saskatoon, dated February 16, 2022 to Minister of Highways and response letter from Minister Fred Bradshaw, Minister of Highways, Government of Saskatchewan, dated March 10, 2022 were provided for information.

General Manager, Transportation & Construction Schmidt introduced the matter and along with Director of Transportation Magus responded to questions related to the timing of the project.

Geoffrey Meinert, Senior Project Manager, Government of Saskatchewan was also present virtually to respond to questions of the Committee.
