

## BYLAW No. 6209

A bylaw of The City of Saskatoon to designate a portion of the South Half of 34-36-5 W/3rd as municipal heritage property.

WHEREAS The City of Saskatoon wishes to designate as municipal heritage property all that portion of the real property described as follows:

All that portion of the South Half of Section Thirty-four (34), in Township Thirty-six (36), in Range Five (5), West of the Third Meridian, in the Province of Saskatchewan, in the Dominion of Canada, which is not covered by any of the waters of the South Saskatchewan River, and containing Two Hundred and Ninety-five (295) acres, more or less, survey dated July 22, 1895; EXCEPT: Seven Hundredths (0.07) of an acre, more or less, shown as Parcel "A" and Fifty-three Hundredths (0.53) of an acre, more or less, shown as Parcel "B", both out of the South East Quarter, taken for Roadway, as shown on a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as No. 67-S-23092, Minerals Included;

which is shown shaded black on the sketch attached hereto and marked as Schedule "A" to this Bylaw, together with the field stone structure, commonly known as "The Old Stone School" or "The Little Stone School", located thereon,

and,

WHEREAS notice of intention to so designate the afore-said real property has been served on the owner thereof and has been advertised in the Saskatoon Star-Phoenix, a newspaper published and circulated in the City of Saskatoon, on the 12th and 26th days of December, A.D. 1981, all according to the requirements of The Heritage Property Act, R.S.S. 1978, Chapter H-2.2; and,

WHEREAS no Notice of Objection to the proposed designation has been served on the City Clerk for The City of Saskatoon;

NOW THEREFORE the Council of The City of Saskatoon enacts as follows:

1. All that portion of the following land, namely:

All that portion of the South Half of Section Thirty-four (34), in Township Thirty-six (36), in Range Five (5), West of the Third Meridian, in the Province of Saskatchewan, in the Dominion of Canada, which is not covered by any of the waters of the South Saskatchewan River, and containing Two Hundred and Ninety-five (295) acres, more or less, survey dated July 22, 1895; EXCEPT: Seven Hundredths (0.07) of an acre, more or less, shown as Parcel "A" and Fifty-three Hundredths (0.53) of an acre, more or less, shown as Parcel "B", both out of the South East Quarter, taken for Roadway, as shown on a Plan of Record in the Land Titles Office for the Saskatoon Land Registration District as No. 67-S-23092, Minerals Included;

which is shown shaded black on the sketch attached hereto and marked as Schedule "A" to this Bylaw, together with the field stone structure, commonly known as "The Old Stone School" or "The Little Stone School", located thereon, is hereby designated as municipal heritage property.

2. The reasons for said designation are as follows:
  - 1) It is one of the earliest structures erected in what is now the City of Saskatoon;
  - 2) It is the third or fourth oldest building extant in Saskatoon and the oldest public structure extant;
  - 3) It is directly associated with the organization of No. 13 School District;
  - 4) It is associated with most early figures of Saskatoon;
  - 5) It is an excellent example of early field stone construction and has experienced no appreciable alteration.

3. UPON the passage of this bylaw, the proper officers of The City of Saskatoon shall do all things and take all proceedings necessary for carrying into effect the provisions of this bylaw.

4. This bylaw shall come into force and take effect on the day of the final passing thereof.

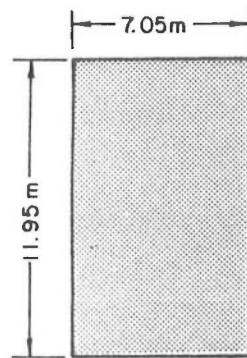
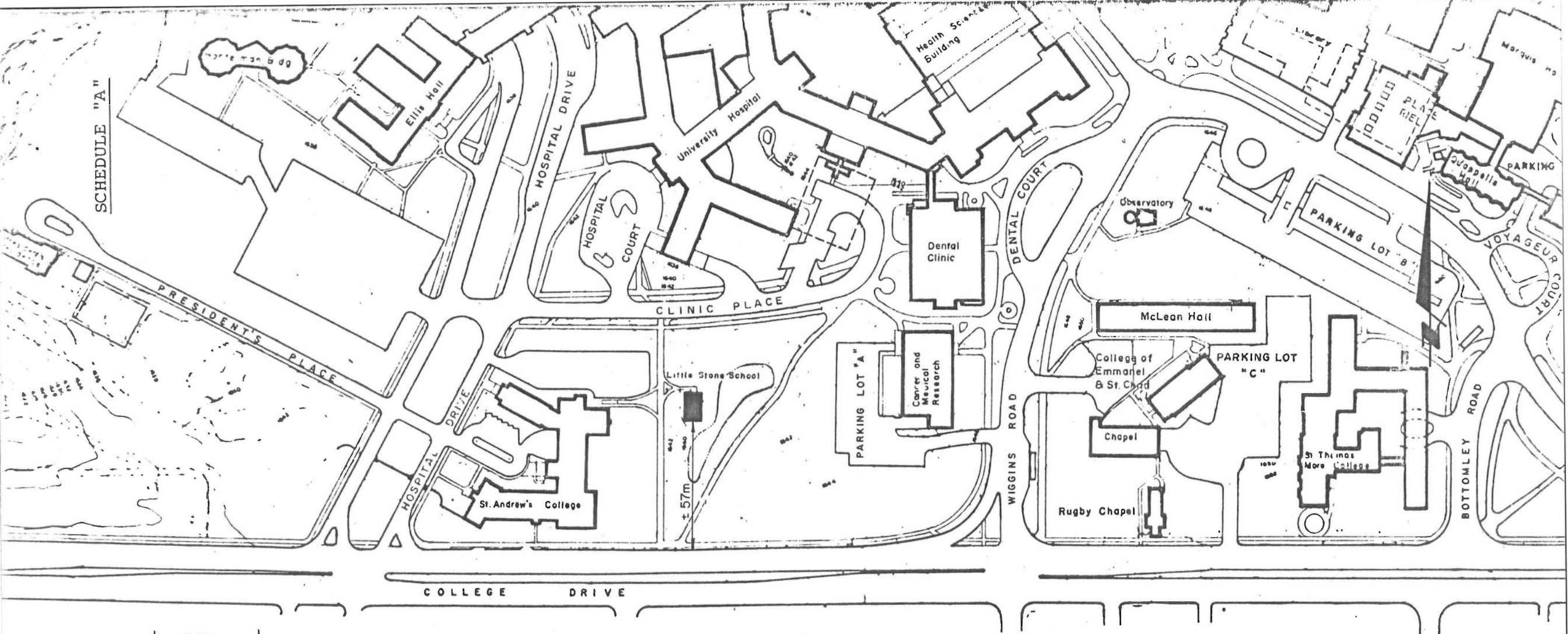
