

## BYLAW NO. 9822

### The Street Closing Bylaw, 2022

The Council of The City of Saskatoon enacts:

#### Short Title

1. This Bylaw may be cited as *The Street Closing Bylaw, 2022*.

#### Purpose

2. The purpose of this Bylaw is to permanently close a portion of undeveloped road on Langham Road, Saskatoon, Saskatchewan.

#### Closure of Portion of Street

3. All that portion of road, more particularly described as:

All that portion of Langham Road, Plan G230 lying north of the easterly production of the northern limit of St/L 1-Plan G230 Ext 0 (Addition to 22nd Street, Plan G230). As shown on proposed road closure plan, prepared by Daniel L. Codling, SLS, and dated May 5th, 2022;

and attached as Schedule "A" to this Bylaw, is closed.

#### Authorization to Carry Out Bylaw

4. The Mayor and City Clerk are authorized to execute all such documents as may be necessary to carry out the intent of this Bylaw.

#### Coming Into Force

5. This Bylaw shall come into force on the day of its final passing.

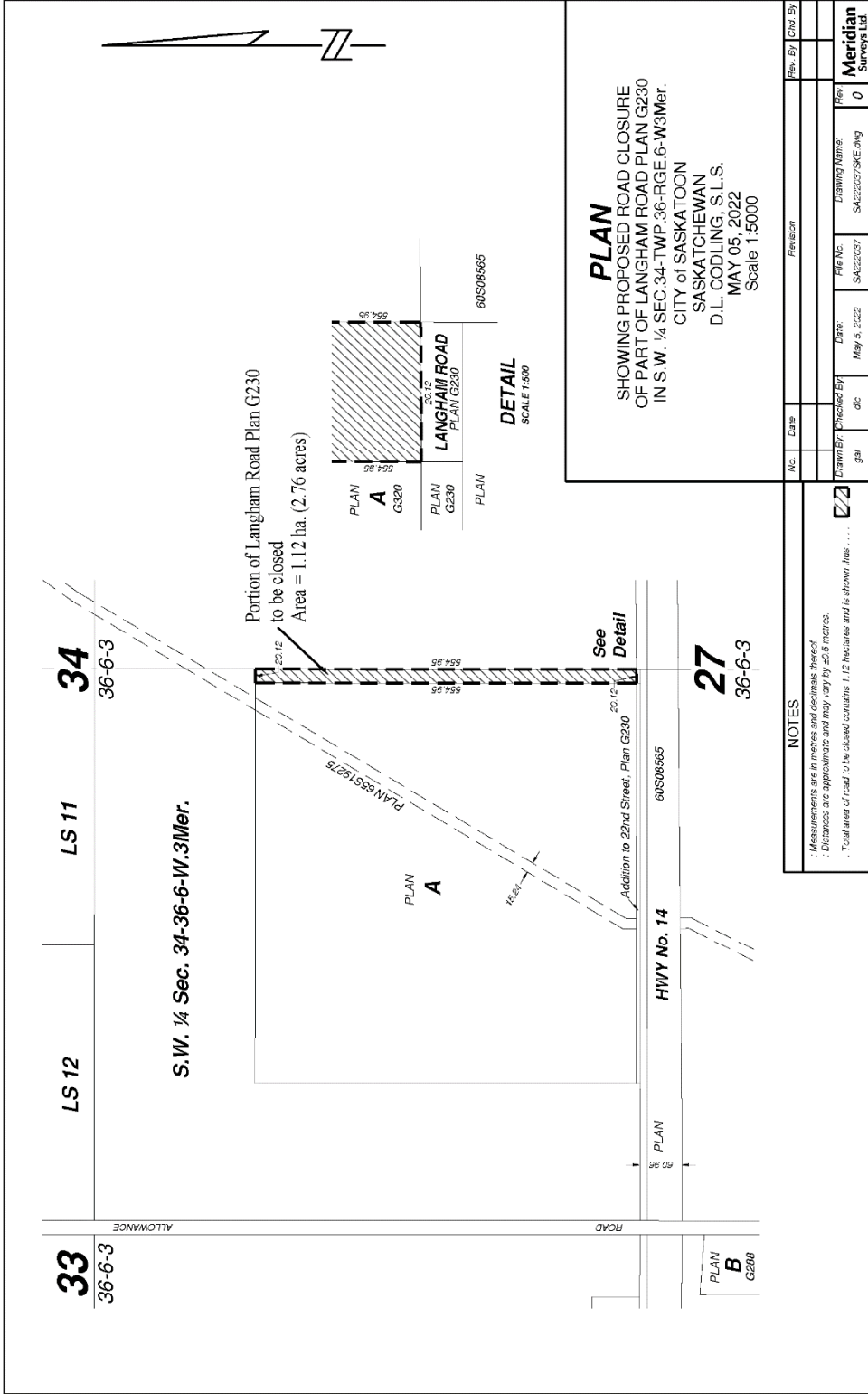
