

**Noise Bylaw Extension Requests to Environment, Utilities & Corporate Services
Committee**

The Special Event Interdepartmental Committee (Administration) consists of representatives from 12 different divisions including Transportation, Facilities, Parks, Parking Services, Transit, Saskatoon Police Service, Saskatoon Fire Department, Emergency Measures Officers, Environmental & Corporate Initiatives, River Landing, Corporate Risk, and Recreation and Community Development.

Administration has reviewed the following noise bylaw extension requests:

1) Filipino Muzik Festival

- a. Event Dates: Thursday August 4th – Monday August 8th
- b. Noise bylaw extension request date: Sunday August 7th until 9:00 PM
- c. Location: Kiwanis Memorial Park (ward 6)
- d. Event Organizers: GKM Events Management
- e. Event background: This is the second year for the Filipino Muzik Festival. Event occurred in 2021 and did not require a noise bylaw extension.
- f. Recommendations: Event organizers have requested a noise bylaw extension until 9 PM. Administration recommends that this extension be approved and is subject to noise bylaw extension guidelines (see attached).

2) Meadowgreen Community Movie Night

- a. Event Dates: Friday June 17th, 2022
- b. Location: Meadowgreen park (ward 2)
- c. Noise bylaw extension request date & time: Friday June 17th until 11:00 PM
- d. Event Organizers: Meadowgreen Community Association
- e. Event background: This is the first year for this event.
- f. Recommendations: Event organizers have requested a noise bylaw extension until 11:00 PM. Administration recommends this noise bylaw extension be approved as requested and is subject to noise bylaw extension guidelines (see attached).

3) ASPA Outdoor Movie Night

- a) Event dates: Saturday June 25th
- b) Location: Kinsmen Park (ward 1)
- c) Noise Bylaw extension request date & time: Saturday June 25th until 11:00 PM
- d) Event Organizers: Administrative and Supervisory Personnel Association (ASPA)
- e) Event Background: This is the first year for this event.
- f) Recommendations: Event organizers have requested a noise bylaw extension until 11:00 PM. Administration recommends this extension be approved as requested and is subject to noise bylaw extension guidelines (see attached).

4) Rock the River

- a) Event dates: Friday August 19th – Sunday August 21st
- b) Location: Delta Bessborough Gardens (ward 6) (private property)
- c) Noise bylaw extension request date & time: Friday August 19th, Saturday August 20th, Sunday August 21st until 10:30 PM
- d) Event Organizers: SaskTel Centre

- e) Event Background: Event organizers have requested a noise bylaw extension until 10:30 PM each evening. Administration received 2-3 noise complaints in 2018 and 2019. In 2019 readings were recorded throughout the event and found to be within the acceptable level of 105 decibels measured 30m (100ft) from the stage or location of the speakers, although complaints were still received. Event did not occur in 2020. In 2021 administration received 1 noise complaint. In 2021 readings were recorded throughout the event and found to be within the acceptable level of 105 decibels measured 30m (100ft) from the stage or location.
- f) Recommendations: Administration still recommends approving the noise bylaw request subject to the following conditions:
 - i. Noise bylaw extension guidelines (see attached)
 - ii. Event organizers are to have record of noise level readings with at least one reading taken every hour and provide a copy to Administration post-event.
 - iii. Allow Administration staff access to the Bessborough Gardens to record noise level readings.
