## **Green Pathways Standing Policy Committee on Environment, Utilities, and Corporate Services on Monday June 6<sup>th</sup>, 2022.**

*This year, the Friends of the Saskatoon Afforestation Areas [Friends] are celebrating the 50<sup>th</sup> anniversary 1972-2022 of the tree planting at the afforestation areas. It is also the Centenary celebration of the International Tree Foundation initiated by Richard St. Barbe Baker. We are taking this time to thank the City of Saskatoon [CoS] for their support in helping with the promotion of these new afforestation stories and the creation of safe urban regional parks at the afforestation areas in the City of Saskatoon.*

*The Green Pathways Report for SPC on EUC shows best practices as the CoS carries forward on the United Nations Sustainable Development Goal 11 Sustainable Cities and Communities and is much to be commended.*

*Time and again, the CoS rallied around the afforestation clean up efforts further promoting UN SDG 12 Responsible Consumption and Production. With the support from the city for environmental protections and restoration work the afforestation areas provide a safe habitat for 24 species at risk in compliance with UN SDG 15 Life on Land. Further to this, the CoS provided support for UN SDG 4 Quality Education as classrooms engage in place-based science and heritage learning. Over 200 students have engaged with the afforestation areas and curriculum package with the Friends, and another 100 are expected in June. The CoS support enabled tours, park visitors during COVID, and also in winter months on track for UN SDG 3 Good Health and Well-Being. The Friends appreciate the advice from the City going forward under the UN SDG 17 partnerships for the goals. The afforestation areas represent nature-based solutions for climate action, UN SDG 13 and show the CoS as a visionary leader in environmental planning. 2022-2032 the International Decade of Indigenous Languages coupled with the 2021-2031 UN Decade on Ecosystem Restoration are compliant with the work being done by the Friends and these are significant parts of the afforestation rich geological, historical, natural, and cultural heritage celebrating the very roots of the afforestation areas. Heritage legacy works, science, conservation, and hands on learning about the land, the environment and sustainability ensure our future. These themes resonate with the CoS Green Pathways report.*

*Saskatoon residents in the very first global City Nature Challenge did make a mark even in the earliest days of spring April 29 – May 2. Saskatoon placed second among 5 registered Canadian Prairie Cities for observers, observations, and identifications. Such standings show the commitment of the citizens of Saskatoon to support vital conservation research while connecting with nature and enjoying the outdoors. The ranking of Saskatoon in the City Nature Challenge came about from the support from the City of Saskatoon, and their recognition of importance in an environmental education opportunity for the citizen scientist amid the general public. Thank you for the recommendations by CoS administration and the help provided to make CNCYXE2022 a success.*
