Issues of added pollution have been expressed and there is a simple technological fix, and that is electric or hydrogen buses. The city can work towards that, but this is still the best route. Not everything in life revolves around driving and parking cars. One can hope that a positive outcome from the BRT on Broadway would be that the consistent bus service would make it more convenient to bus to Broadway than to drive, which would ease the congestion that already exists.

I am writing to voice my support for dedicated lanes for BRT routes on Broadway avenue, and either 1st or 3rd ave downtown.

As person with an invisible disability, and as a person who works with socially and economically disadvantaged people, many of whom also have disabilities, I see on a daily basis, the impact that lack of access to a personal vehicle can have, within the context of urban life in a city that centers many of it's decisions around motorists. I myself had to purchase a vehicle and stop using city transit a few years ago following an injury and the worsening of my invisible disability. I was lucky to be able to do so, and I know many people don't have that option. I have used public transit in other provinces and countries and had far fewer issues meeting my needs with that form of transportation, but in Saskatoon I was finding it impossible to get to appointments, therapies, and get all my errands done using city transit. I truly believe moving towards more BRT routes and investments in public transportation would allow me and many other people to lead healthier lives, and would also transform the city in positive ways.

This is a human rights issues, and to consult with "business owners" on the proposed BRT routes and to suggest that they have equal say in this matter is also ableist and unjust. To limit or alter routes, in the interest of business owners and motorists, is to place the importance of business and capitalism over the importance of each community member's attempts at upward mobility, health, and connection to community. The impact of proposed BRT route options on business owners and the impact on community members is not symmetrical and should not be treated as such. Safe mobility is a human right. Owning a business is not.

Not only do I think that city council should oppose options 2 and 3 (mixed lanes/no change). You should also take an active and progressive approach toward engaging and calling in opponents, de-polarize the issue using whatever access you have to different media.

First and foremost, I want to acknowledge that the decisions before you are not inconsequential and appreciate that their weight must be a heavy burden to bear.

I wish to express my support for the implementation of the BRT and strongly support the 1st Ave and Broadway routing. Beyond the lack of consensus regarding the final routing, the merits of the BRT are muted in comparison to the separated downtown bike lanes. Should the dedicated bike lanes go forward, my preferred option of the N-S spine of the bike network would be 3rd Ave for reasons of best connectivity and options for expansion at either end. The rest of this letter addresses the bike lanes.

Much of the discussion around the downtown bike lanes that I have personally engaged in, and have witnessed in the news and social media has revolved around the merits, pros and cons, of the options before you. Surprisingly though, what hasn't really seemed to be discussed is that these decisions have broader long-term implications and will dictate how we collectively decide to develop and move around our city going forward. This is indeed a watershed moment and I don't think that most seem to get beyond taking a self-interested perspective and get lost in the details of lost parking spaces, congestion, personal convenience, potential effects on business, name your talking point, etc. If we filter out all the noise, what is really being debated here is whether we are going to continue to let auto-orientated development continue to dictate just about every aspect of our civic daily lives (at the cost of everything else)? I encourage you as Council to look beyond the dissenting

voices (though very numerous), and consider what is the most efficient, resilient, and cost-effective way to move forward. Research, history, common sense, and logic will confirm that it isn't single-occupant automobiles (including autonomous).

It should be apparent, but the pendulum has swung so far to one side on this matter that going back the other direction is sure to cause disruption in the businesses and lives of many; I'm sure many people have tried to make you aware of this in the last few years. I don't argue this, some concerns are likely valid, but most are blown out of proportion in a distorted market that rewards personal over-consumption of public goods, and are rooted primarily in the promotion of self-interest. But I have to ask based on this continued approach: Are

municipal finances improving? Infrastructure commitments and liabilities going down? Are municipal taxes going down and levels of service going up? Is there a perceived safe environment provided for all people who choose to cycle downtown? Is it current mode share environmentally efficient? Does it promote social equity? I could go on, but the answer to all is a resounding NO. Should we not then be taking a more aggressive and unconventional approach to try to improve these things?

I hesitate at even drawing attention to the immense importance of these decisions as there still seems to be a few of you who seem bent on maintaining the status quo to maintain favour amongst the majority of your ward residents (people talk and share your responses to their letters) and repeating the mistakes of the last 100 years when it comes to land use and transportation planning. I just don't get it and I fear bringing attention to what is truly at stake here because it sounds like some of you are going to choose wrong because the fear of change and backlash is too great. I don't build a case not to make a necessary change. Delaying or putting it off for a couple years until other aspects of the ATP are implemented, or when the "timing is better", is not good either. This is a flaming emergency that requires course correction now.

I implore Council, please LEAD on this matter. Many, if not all of you, have said at various times in the lead up to this decision, something along the lines of "this is what I am hearing from my residents"; or something similar. We did not elect you to simply execute the will of the majority of ward residents. Leading is different, and often the opposite of representing the majority public opinion. Very few will ask or support something that will change an aspect of their daily life, nevermind if they further perceive it to affect them for the worse - this is human nature. But that gets us nowhere and we will continue to amplify the same problems. We need Council to consider these decisions rationally and take a stand for what might not be popular and what might be challenging, and in all of our long-term best interest.

Relevant personal background:

-I have cycled year-round as a form or commuting starting in grade 6 (early 90s). I have yet to encounter conditions that were unmanageable in Saskatoon. Even though we can get deep cold, cold and dry makes for completely manageable conditions and is far better than wet or melt.

-Until recently worked downtown and commuted year-round by bicycle as it was the most efficient option with respect to time and costs.

-Used the 4th Ave bike lanes daily

-Comfortable riding in auto traffic; preferred them to the poorly implemented trial lanes.

-We manage with 1 household auto. Consciously choose to minimize use where possible, but do still drive.

A vast majority of community, merchants and Nutana folks as well as former Saskatonians and tourists are aghast at the suggestion of a BRT corridor on Broadway Avenue.

There is another BRT option which the majority agree would be favourable : Eighth Street, across Sid Buckwold Bridge to First Avenue.

I am baffled that the mayor and City Council disregard this option and hold to Broadway as their choice despite a vast majority who oppose it.

Joni Mitchell's lyrics 'you don't know what you've got till it's gone...' ring true for the majority of our tax payers and community at large.

This disconnect between City Council and voters is disheartening. Saskatoon's strength and success is built on strong community sharing a common vision to do something remarkable. The Mayor refers to it as collaboration. In this case City Council has a vision which is clearly not shared by the majority. Collaboration cannot be expected.

Associations, groups, businesses, merchants, community members have come forward through letters, petitions and presentations demonstrating clear evidence of their opposition to the BRT on Broadway. The Mayor and Council defy the majority.

Our city is nothing without its members and its tax payers. This disconnect will weaken our Public Transit System, weaken The BRT that our ever increasing taxes are paying for and especially it will weaken the faith we have in true democratic representation which results in the collaborative spirit that has developed over many years.

Many will not attend this Council meeting April 29, 2019 as it is seen as a mockery of community and democratic leadership to those who have spent time and energy only to witness this new reality in the governance of our city.

It is difficult to endure this heart breaking reaction to the cry of a caring community. The outcome is already clearly decided by the city recommendations for the BRT.

Along with a vast majority of the community of Saskatoon, I support a BRT route across Sid Buckwold Bridge to First Avenue.

The majority of Saskatonians are hoping for a Mayor and City Council who believes in them and who works with them in a true collaborative effort.

I have been a resident of Saskatoon for over ten years and for the past four years I have had the pleasure of residing in Nutana. I moved to Saskatoon in order to attend the university and ever since have been reliant on the transit system to take me from the many different areas I have previously lived in to the university campus. Like many university students, I've had my fair share of difficulties with the quality of our transit system with regards to the limited bus schedule. I am thrilled to learn about the possibility of introducing Bus Rapid Transit for this reason. Today, I would like to extend my support for the implementation of dedicated bus lanes on Broadway avenue. First I would like to point out the challenges that the Broadway area faces with vehicle congestion and parking issues. Most parking is only available in residential areas making it problematic for local residents to find parking on their own streets. The parking found directly on Broadway is also minimal, allowing for only a couple of parking spots allotted per business. Therefore, I believe that making transit more accessible via BRT and dedicated bus lanes will encourage more people to visit the Broadway area by public transit considering it will remove the worry about finding parking while also resolving the issue of having to wait for the next bus to return home. Second, introducing the dedicated bus lanes to Broadway ave specifically is necessary in that people will be more likely to take the bus if they can arrive as close as possible to the places of business they wish to visit. Which brings me to my final point. I felt personally victimized by many of comments I heard from local business owners on Broadway. The opposition toward BRT appears to be stemming from a place of privilege and prejudice. Many of us are unable to afford vehicles, but would still love to be able to visit Broadway for ethically sourced hand made goods from underdeveloped regions or to enjoy the aromas of

fresh roasted coffee beans. To assume that the only people who are supporting local businesses are those who are driving in from the suburbs is flawed. Many low income earners, university students or and people who want to safely enjoy a few drinks on Broadway with a guaranteed safe ride home are also supporting those businesses. Finally, I would like to encourage you to consider those who this decision is going to affect the most. It is those who are reliant on the transit system for accessibility within our city. Those who have vehicles are already at an advantage. Today, I ask you to vote in favour of dedicated bus lanes on Broadway avenue to ease the struggle for those who are at a disadvantage in our city.

Obviously, Council has not been listening to the area businesses and/or the citizens of Saskatoon regarding the BRT route. They are also misleading those who have not been following as closely as many of us have, the travesty that is BRT on Broadway.

To be clear, I am not against the BRT. In fact, I do feel it would help in the future as we grow, to have a wellplaced system. Having it on Broadway, however, will actually "bypass" the businesses as riders make their way back from work to their suburban homes. There is no need to remove regular bus traffic on Broadway (why would you?), so access is still available to the business district. You will not be "bypassing" Broadway as you misleadingly suggest.

Having read the options and noting that there are two options that have not had proper public engagement – both of which seem to indicate that Council and its administration really have no idea of best outcomes – I would suggest a deferred decision-making process until the two options are properly and publicly explained and discussed.

I also see by your update that Council has not addressed "business, culture or the environment – all vital to the preservation of this historic area". The BRT is not an underground system and will create a dangerous mess in an area where there are two school zones as well as Nutana School (not to mention an increasing elderly population who have remained in the area precisely because it is a nice place to walk with all of the amenities). Placing BRT on Broadway (whether with dedicated lanes, or not) will also have a dampening effect on this pedestrian traffic and will result in special events moving away from Broadway, not to Broadway.

This is not a small decision as the Broadway route would still destroy the walkability and culture of the area. I also question the numbers against vs the numbers for a Broadway selection ("an engagement event" is not ALL engagement events and does not include the recent poll in which more than 75% of respondents voted against a Broadway option).

Currently, I see a council with no vision or concern for what really works for culture, community and tourism destinations and that makes a mockery of the concept of "collaboration". The misinformation and disinformation, much of it perpetrated by Council itself (e.g., the suggestion that, if Broadway is "bypassed", the downtown entertainment area of the future will take over…hogwash), does not help at all. It is an excuse to cover up poor decisions.

As you can see, I feel passionately about these changes precisely because, having lived in this area for 42 years, I have seen what a seemingly small change can do. I believe BRT on Broadway will change the area from charming to outright dangerous...or, at the very least a local business wasteland. It will lose its unique historic character that is so much a part of the history of Saskatoon itself.

I am saddened by this irresponsible decision-making process, and hope that Saskatoon's City Council will give this misstep more thought.

As the city grows, the need for safe cycling lanes becomes imperative. Even now, as a cyclist, I fear for my safety riding some streets in Saskatoon. When possible, I confine my riding to side streets. Never will I ride my bike on the street side crossing the river on either the Broadway Bridge or the University bridge. It seems to me, where bike lanes are not possible, sharing sidewalks with pedestrians is a much safer option. Issues of added pollution have been expressed and there is a simple technological fix, and that is electric or hydrogen buses. The city can work towards that, but this is still the best route. Not everything in life revolves around driving and parking cars. One can hope that a positive outcome from the BRT on Broadway would be that the consistent bus service would make it more convenient to bus to Broadway than to drive, which would ease the congestion that already exists.

In regards to the bike lines, I fully agree with Administration, and highly encourage Council to adopt Option 1, and establish the Downtown Active Transportation Network along 3rd Avenue, 19th Street, and 23rd Street. As a pedestrian and a biker, I know there is value in moving forward with the protected cycling network downtown.
