Dear Mayor Clark and Members of City Council,

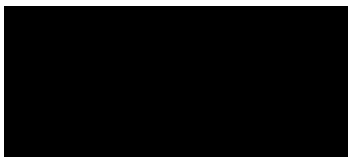
On behalf of the Saskatchewan Place Association (SaskTel Centre) Board of Directors, we are pleased to see a site will be selected for Saskatoon's downtown event center and entertainment district. The location and imminent development of the north parking lot of Midtown Plaza has the full support of our group.

We know there are significant benefits to this location, including the proximity to Midtown Plaza, current hotels, restaurants, and most importantly, TCU Place.

As the largest event producer in Saskatchewan, this proximity to TCU Place will allow more cross-venue programming for Saskatoon. This is particularly important for attracting large-scale international and national events which require additional space beyond an arena (ie. ancillary locations for events such as the Brier Patch or convention meeting space for the JUNO Awards). This configuration is the future for these types of events and will increase the desirability of Saskatoon as a host city.

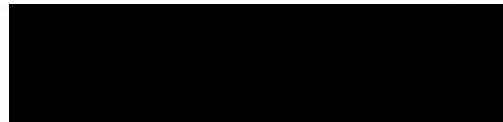
We recognize that the site-selection was just one step in a multi-step process and enthusiastically express we fully support this first step in solidifying the location.
