On behalf of the Downtown Entertainment and Event District Advisory Committee, I am writing in support of the Administrations recommendation to approve Site A – Midtown Shopping Centre North Parking lot be the location for the future Downtown Entertainment and Event District.

The DEED Advisory Committee is comprised of community members that represent the diversity in Saskatoon. As appointed members representing the community and member-based organizations, we are responsible for representing the voices of the community members we serve. Our perspective, leadership, experience, and consideration of Saskatoon’s ability to be a thriving community for all is guiding City Council and Administration to make calculated and informed decisions.

It is clear to the DEED Advisory Committee that this location presents the most favourable opportunity to become a “destination” in Saskatoon’s downtown core.
