**RE: Downtown Event and Entertainment District**

The Riversdale Business Improvement District (RBID) Board of Management has remained steadfast with the support for the Downtown Event and Entertainment District.

With initial discussions dating back several years ago the RBID has stated that if the Downtown Arena and Convention Centre is not located in Riversdale, that it be located as close as possible to Riversdale. Citing the benefits of cities who have chosen to invest in their Downtown areas with not only improved physical and financial benefits, but also increasing the quality of life for citizens living and visiting here. The attraction and desire to live closer to centre city districts with more amenities, services and entertainment options delivers returns on existing infrastructure and benefits many of the City of Saskatoon's core strategies.
