NSBA Preferred Site for Downtown Event and Entertainment Arena

To Your Worship and Members of City Council,

As mentioned in previous letters, messages and news releases, the NSBA has long supported the development of a Downtown Event and Entertainment District. We believe there are significant economic benefits, tourism opportunities and investment attractions the project will ignite in our City's downtown.

The last time an entertainment arena was being debated in the City, the debate then was whether to build it in the north end or don't build. Today, we have two site options located in our downtown, and the NSBA reiterates that **SITE A – Midtown Shopping Centre North Parking Lot** is the perfect option. The Site fits remarkably well with the City's overall growth strategy, and with the City's recent survey result, the Site has proven to be the best option in every criterion.

Having this facility, located in the north parking lot of Midtown, would have a profound positive impact on our community in ways such as:

- Expansion and connection opportunity for TCU Place
- Proximity to other relevant current infrastructures, such as Midtown Plaza and nearby hotels
- Development of a Stronger Transportation Network
- Opportunity for small and medium size businesses nearby
- Development opportunities for the major streets adjacent to the Site

In closing, this is an opportunity for us to create a more vibrant downtown with an anchor that will attract other investments, presuming it's in the right location. It's critical that we get this decision right, as it will have a long-lasting effect into our future.
