5.2 Downtown Event and Entertainment District – Land Acquisition - Midtown Plaza North Lot [CK 4130-14]

A report of the Administration was provided.

City Manager Jorgenson provided an introduction regarding the matter.

- 1. That the Administration be authorized to purchase the Midtown North Lot, civically known as 140 Pacific Avenue, and legally identified as Parcels A and E, Plan 64S20563, Extensions 2 and 3, Surface Parcels 135771778 and 135771813, consisting of approximately 5.28 acres or 229,998 square feet at a purchase price of \$25 million for a potential Downtown arena/event centre;
- That the City Solicitor be requested to prepare the associated auxiliary, undertaking and assignment agreements for signature, and that His Worship the Mayor and the City Clerk be authorized to execute the agreements under the Corporate Seal; and
- That if the purchase of the North Lot is approved by City Council, the Administration be authorized to enter into an interim parking operation and management agreement with Midtown regarding parking on the North Lot after the closing date.
