BYLAW NO. 9855

The Official Community Plan Amendment Bylaw, 2022

The Council of The City of Saskatoon enacts:

Short Title

1. This Bylaw may be cited as *The Official Community Plan Amendment Bylaw*, 2022.

Purpose

2. The purpose of this Bylaw is to amend Bylaw No. 9700, the Official Community Plan, to make minor edits to improve use experience; to make housekeeping amendments and updates to language.

Bylaw No. 9700 Amended

3. The Official Community Plan which is annexed as Schedule "A" to Bylaw No. 9700 and forms part of the Bylaw, is amended in the manner set forth in this Bylaw.

Table of Contents Amended

4. The first page identified as "TABLE OF CONTENTS" is amended by striking out "OCP" wherever it appears and in each case substituting "Plan".

Section A Amended

- 5. Section A Introduction is amended by:
 - (1) adding an "A" immediately preceding subsections "1", "2", "3", "4", "5", and "6";
 - (2) striking out "Province of Saskatchewan" in the second paragraph of subsection 1 and substituting "provincial government"; and
 - (3) striking out "Budgeting" in the first paragraph of subsection 4 and substituting "Budget".

Section B Amended

- 6. Section B Our Local Context is amended by:
 - (1) adding a "B" immediately preceding subsections "1" and "2";

(11) adding an "E" immediately preceding clauses "6.1" and "6.2".

 - (4) repealing "Map 2 Downtown Land Use" following Map 1 Downtown and City Centre after subparagraph 1.1(2)(b)(ii) and substituting it with "Map 2: Downtown Land Use" as shown on Appendix "B" to this Bylaw:
 - (5) repealing "Map 3 Planned Growth" after paragraph 1.3(2)(c) and substituting "Map 3: Planned Growth" as shown on Appendix "C" to this Bylaw;
 - (6) adding a "G" immediately preceding clauses "2.1", "2.2" and "2.3";
 - (7) adding a "G" immediately preceding clauses "3.1", "3.2", "3.3", "3.4", "3.5" and "3.6";
 - (8) repealing paragraph 3.3(2)(e) and substituting the following:

- "(e) Facilitate supportive housing forms and tenures, such as residential care homes; custodial care facilities; day care or day programs; day care or day programs, residential; family shelters; and other forms of supportive housing, in all areas of the City.";
- (9) adding a "G" immediately preceding clauses "4.1" and "4.2";
- (10) adding a "G" immediately preceding clauses "5.1", "5.2" and "5.3";
- (11) striking out "Corman Park Saskatoon Planning District Official Community Plan" in paragraph 5.2(2)(c) and substituting "Saskatoon North Partnership for Growth District Official Community Plan";
- (12) striking out "Corman Park Saskatoon Planning District Official Community Plan" in subparagraphs 5.3(2)(a)(ii)(A) and (B) and substituting "Saskatoon North Partnership for Growth District Official Community Plan";
- (13) striking out "5.3(2)(iv)" in paragraph 5.3(2)(a)(v) and substituting "5.3(2)(a)(iv)";
- (14) striking out the heading "6.1 General"; and
- (15) striking out "corporate" in subclause 6(2)(b).

Section H Amended

 - (7) adding a "J" immediately preceding clauses "5.1", "5.2" and "5.3".



Coming into Force


16. This Bylaw shall come into force upon receiving the approval of the Minister of Government Relations.




