Dear His Worship the Mayor and Members of City Council:

Re: 2022 Annual Report – Saskatoon Board of Revision (BOR) (CK. 430-77)

In accordance with the Board of Revision's Policy and Procedures, as the Chair of the Board of Revision, I hereby submit the Board's 2022 Annual Report for City Council's information.

Background

Section 192 of *The Cities Act* provides for the establishment of a Board of Revision to deal with appeals arising from assessment procedures. The Board of Revision is set up as an independent administrative tribunal whose main function is to hear assessment appeals filed by any person or property owner.

Changes to legislation and decisions from the Court of Appeal have clearly established that the Board of Revision is the tribunal of record in the assessment appeal process. Persons wishing to appeal their assessments must present evidence before the Board of Revision to show that an error has been made. Appellants are precluded from presenting new evidence before the Saskatchewan Municipal Board, Assessment Appeals Committee, except in very minimal circumstances. Appeals before the Saskatchewan Municipal Board are based upon the record of the hearings before the Board of Revision.

Reassessments occur every four years and the year **2022** was the second year of reassessment based on property values for the Province of Saskatchewan as of **January 1, 2019**.

In 2009, the entire province of Saskatchewan moved to a results-based mass appraisal market system for most properties. Major changes for commercial, industrial and investment properties took place in the 2009 reassessment in that the Income Approach (Rental Income) to value was allowed. Hearings before the Board of Revision have become more complex over the years. As the City of Saskatoon has grown, so has the number of tax appeals, particularly in a reassessment year. The increase in the volume of appeals has led to a corresponding increase (or loss thereof) in revenue to the City/Appellant/Tax Agent. Board members have had to learn and understand the technical aspects of the Assessor's models. In addition, the inclusion of Legal Briefs has become more common. This has required Board members to become increasingly knowledgeable with regard to the judicial aspect of property taxation.

An assessment appeal history for the years **2017-2022** is attached as **Appendix D**.

As part of the City's comprehensive governance review, City Council, at its meeting held October 25, 2021, resolved, in part, that an annual ad hoc Recruitment Committee including two members of City Council, the Board of Revision Secretary, and the Board Chair, be established to screen applicants and make recommendations for appointment or reappointment to City Council. The Board Chair and Secretary had an opportunity to participant in this process in 2022 for the 2023 Board of Revision appointments/reappointments, this was a positive experience, and we would like to thank City Council for the opportunity.

In 2021, the Saskatchewan Government established the Office of the Registrar, within the Ministry of Government Relations along with regulations to establish a certification process for all Boards of Revision, outlining responsibilities of the assessment appeals Registrar, and requiring all Boards of Revision to be certified in order to hear property assessment appeals.

For a Board of Revision to be certified, all Members and Secretaries must take an Oath of Office and successfully complete an online training program developed through the Johnson Shoyama Graduate School of Public Policy. The initial certification and training requirements will be monitored every year starting with 2023 and for the first five years

including 2027. As of yearend 2022, the Saskatoon Board of Revision Members and the Secretary have successfully completed the training and the Board has been certified by the Ministry of Government Relations to hear 2023 assessments.

The development of the skills, knowledge and expertise of a Board of Revision requires considerable time, and as such, the Board encourages City Council to continue to consider the extension of appointments of Board members beyond the six-year maximum term, particularly in reassessment years.

Appeals and Hearings - 2022

Mailing of Assessment Notices by the Assessor was on January 4, 2022. The deadline to appeal was February 4, 2022. The 180-day deadline for the BOR to complete its duties was July 4, 2022. The Board received 942 Notices of Appeal in 2022, which includes appeals on regular assessments, amended assessment as well as supplemental assessments. **Appendix A** is a summary of results of appeals heard by the Board of Revision in 2022.

A summary of Board member time for 2022 and the correlating second years of the previous reassessment cycles, is attached as **Appendix B**. It is important to note that the legislation provides for the parties to an appeal to file an "Agreement to Adjust" (ATA) with the Board of Revision Office; thereby, reducing the number of appeals that require a hearing.

Decisions of the Board of Revision can be further appealed to the Assessment Appeals Committee, Saskatchewan Municipal Board (SMB). There were 337 decisions of the Board of Revision appealed to the SMB in 2022. The hearings for these appeals are currently being scheduled by the SMB, and it is expected that it will be some time until those decisions are rendered. The Board in 2022 saw a number of Board of Revision Appeals on Amended Notices being appealed to the SMB.

Appendix C provides a summary of results for the Board of Revision and the Assessment Appeals Committee, Saskatchewan Municipal Board, for the year 2022.

As in past years, the Board wishes to commend the Board of Revision staff for their skill and knowledge. The expertise of the staff greatly contributes to the success experienced by the Board of Revision.
