SOS Trees Coalition [http://www.sostrees.ca/](http://www.sostrees.ca) support the Swale Watchers proposal that is based on the principles of Biodiversity Sensitive Urban Design, that will protect, connect and restore this natural system while also providing quality, family homes in an exceptional setting.

We were disappointed to see that the Administration proposal for University Heights III, is not adequate to ensure the long-term viability of the Northeast and Small Swales. The Swales are two of Saskatoon's most important and valued natural areas that remain somewhat intact. provide critical habitat and offer a variety of ecological services. Where else in Saskatoon can you walk and encounter deer, watch a raptor soar or smell the scent of wild grasses?

We urge Council to reject the Administration's current proposal and to accept the proposal from the Swale Watchers to protect these natural spaces while developing a more sustainable neighborhood.
